Discussion/Direction/Action: The Pima County Sheriff's Department has completed its Internal Affairs (IA) investigation into the sexual assault that occurred between a Pima County Sheriff's Department sergeant and a deputy in December of 2022. In 2023, the Board of Supervisors asked the Attorney General's Office to do an independent investigation into the Department's internal response to the assault, to see if any laws or protocols had been broken. In its response dated August 29, 2024 (included in attached CA memo) the Attorney General's Office noted that while it did not appear that any laws were broken, there were various Sheriff's Department policies that "may have been violated by command staff". The AGO concluded: "We understand that additional information will be developed during an IA investigation which may provide explanations or justifications for these areas of concern. The AGO would welcome the opportunity to review the IA investigation after it is completed by the Sheriff's Department should this Board continue to have concerns." Now that the Sheriff's Department's IA investigation is complete, directing the County Administrator to ask the Attorney General's Office to review the Department's IA investigation and any related matters, to ascertain if any laws or protocols were in fact broken.

Re: Response from the Attorney General's Office regarding Request for Independent

Investigation

On September 19, 2023, the Pima County Board of Supervisors voted to request an independent investigation by the Office of the Attorney General of actions taken by Sheriff Nanos in review of an alleged sexual assault of a female deputy. Of particular concern to the Board was the manner in which the internal investigation was to be conducted by the Sheriff's Office.

On Friday August 30, 2024, I received the attached response from Nicholas Klingerman, Chief Counsel of the Criminal Division of the Attorney General's Office. Mr. Klingerman reports that investigators within the Attorney General's Office have conducted a review of the provided investigative materials. It is noted that since Sheriff Nanos is waiting for the criminal trial to end before launching the Internal Affairs (IA) investigation into the incident, the IA investigation has yet to be completed.

The Attorney General's Office found no criminal wrongdoing in the investigative process. The Office did, however, note four rules of the Pima County Sheriff's Department that may have been violated.

- "All members are required to take appropriate police action toward aiding a fellow police peace officer or department member exposed to danger or in a situation where danger might be pending." This policy may have been violated by command staff.
- 2. "A member shall act in an official capacity, whether on or off duty, if an incident is observed which requires policy action and time is of the essence or when such action will safeguard life or property, preserve the peace, or prevent the escape of a criminal. All responses must be consistent with the responses of an on-duty member." This policy may have been violated by a sworn police officer who was off duty but on scene.
- 3. "Supplemental Reports should be submitted when commissioned members participate in law enforcement activities requiring a case report to document their involvement in the incident." This policy may have been violated by command staff who were on scene or received direct reports but failed to document their involvement.

4. "Unless otherwise approved by a supervisor, all property and/or evidence shall be packaged and secured in an approved property and evidence locker or delivered to the P&E Unit prior to the end of shift." This policy may have been violated by a detective failing to properly secure evidence.

The Attorney General's Office noted their willingness to review the IA investigation after it is completed by the Sheriff's Department should the Board continue to have concerns.

Re: Request for Independent Investigation by the Attorney General's Office

Dear County Administrator Lesher,

In response to your request for the Arizona Attorney General to review the actions taken by Sheriff Nanos in his department's review of an alleged sexual assault of a female deputy in December of 2022, investigators within the Attorney General's Office have conducted a review of the investigative materials developed in that case and provided to us by the Pima County Sheriff's Department. We note that an Internal Affairs (IA) investigation into this incident has yet to be completed, and that Sheriff Nanos has indicated a plan to wait until the end of the criminal trial to begin the IA investigation. We found no criminal wrongdoing in the investigative process; however, based on our review of the materials, we are concerned about the following possible violations:

• Pima County Sheriff's Department General Order 2022-034, Chapter 5(I)(A)(5)(c)(7) provides "All members are required to take appropriate police action toward aiding a fellow police peace officer or department member exposed to danger or in a situation where danger might be pending." Based upon the content provided to the Arizona Attorney General's Office, this policy may have been violated by command staff who were notified of the situation and/or responded to the scene, but provided limited or no assistance to department members dispatched to the scene.

- Pima County Sheriff's Department General Order 2022-034, Chapter 5(II)(C)(1) provides "A member shall act in an official capacity, whether on or off duty, if an incident is observed which requires police action and time is of the essence or when such action will safeguard life or property, preserve the peace, or prevent the escape of a criminal. All responses must be consistent with the responses of an on-duty member." Based upon the content provided to the Arizona Attorney General's Office, this policy may have been violated by a sworn police officer who was off duty, but on scene, and failed to immediately report the incident or observed conduct to emergency dispatch or on-duty department members.
- Pima County Sheriff's Department General Order 2022-026, Chapter 5 (XXI)(B)(1) provides "Supplemental Reports should be submitted when commissioned members participate in law enforcement activities requiring a case report to document their involvement in the incident." Based upon the content provided to the Arizona Attorney General's Office, this policy may have been violated by command staff who were on scene or received direct reports from witnesses involved in this incident but failed to document their involvement with reports.
- Pima County Sheriff's Department General Order 2020-007, Chapter 4 (IV)(C)(4) provides "Unless otherwise approved by a supervisor, all property and/or evidence shall be packaged and secured in an approved property and evidence locker or delivered to the P&E Unit prior to the end of shift." Based upon the content provided to the Arizona Attorney General's Office, this policy may have been violated by a detective failing to properly secure evidence with the Property and Evidence Unit prior to the end of the detective's shift.

We understand that additional information will be developed during an IA investigation which may provide explanations or justifications for these areas of concern. The AGO would welcome the opportunity to review the IA investigation after it is completed by the Sheriff's Department should this Board continue to have concerns.
