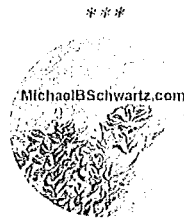

Dear Supervisors:

Two issues regarding the upcoming appointment of a replacement for former Supervisor Bronson:

1. The appointed person should NOT be running in the 2024 election because this would give the appointee an unfair advantage in both name recognition and the perception of a type of endorsement.
2. Voting should NOT occur using any form of Ranked Choice Voting, which is a convoluted approach to put the most popular candidate at a disadvantage and push another group's agenda. Only someone with manipulation in mind would consent to Ranked Choice Voting.


Dear Pima County Board of Supervisors:

As you approach the challenge of filling the tremendously large shoes left empty by Supervisor Sharon Bronson's recent resignation, I ask that you prioritize representation from the rural and unincorporated communities of Pima County District 3 in the decision-making process. The make-up of the current Board of Supervisors is, and will necessarily continue to be, dominated by Tucson-centric points of view. While it is understandable that having most of the county's population in Tucson would command a majority level of representation, District 3 is functionally the only seat where it is realistic and appropriate to have a supervisor who deeply understands what it is to live in rural and unincorporated Pima County.

While it is easy enough for an applicant to pay lip service to the importance of reaching under-represented communities in District 3, until one has lived in a place where there is no locally elected government and there is no truly representative voice, it is difficult to understand this reality. There is a surfeit of Tucson-based organizations that include places like Ajo, Arivaca, and the Tohono O'odham Nation in their service areas, but these places remain underserved because you can't meaningfully reach hard-to-reach communities with remote services...even with best intentions.

You are in a position to ensure that rural and unincorporated Pima County are appropriately and meaningfully represented. I ask you to exercise that power.

In just a few days you will be voting on a replacement for District 3 Supervisor, and I write this letter in full support of Kristen Randall.

On January 1, 2024, I will finish my first full year in this very challenging yet incredibly rewarding position. Upon my arrival at Ajo Justice Court it was pretty apparent we had numerous challenges to overcome such as staffing, dated technology and years of courthouse neglect. Kristen offered her assistance from Day 1 and her knowledge and expertise allowed us to move mountains in just a short amount of time. These improvements helped increase our ability to serve more efficiently, increased our visibility, as well as access to our court.
