Re: Cancellation of Flowing Wells Irrigation District 2022 Annual Election

Dear Ms. Manriquez:

I am writing on behalf of Flowing Wells Irrigation District (District) to request the cancellation of its November 15, 2022 annual election. The District has one position on the Board of Directors to be filled at the November 15, 2022 election. Only one nomination petition has been filed or write-in affidavits for this position.

A.R.S. 16-410 allows that if the number of persons who file nomination petitions plus the number of persons who file write-in affidavits is less than or equal to the number of positions to be filled for a water district election, the Board of Supervisors may cancel the election and appoint the person or persons to fill the position for the term of office for which the candidate was nominated.

Therefore, it is respectfully recommended canceling the District's uncontested November 15, 2022 election and appoint Eric J Myrmo to serve a three-year term, effective January 1, 2023. If you need further information, please contact me. Thank you.
