I am a parent, citizen and voter in Pima county with daughters at the middle school and high school levels. I coach children from ages 7-16 throughout any given school year. I have a 19 year old son who attend university at the UofA and coaches middle school basketball. Supervisor Rex Scott:

I have more than 25 years of experience writing about protecting and promoting health in both mainstream books and magazines. I am writing to urge you to vote no on requiring all healthcare workers to get an unproven, experimental shot that was approved for MERGENCY USE ONLY!!!!. Your actions are ludicrous! Your health care employees who worked long hours and in 2020 were called heroes are now being threatened with their jobs if they exercise their legal and God-given right of free choice to make their own medical decisions.

First off, the premise for the emergency use authorization of the so-called COVID VACCINE is flawed because you can only have experimental use authorization if there are no therapeutics that work. That is false. COVID-19 is a coronavirus, as is the seasonal flu and the common cold. The only difference is that it didn't occur in nature, but was engineered in the Wuhan lab and released into the general public either intentionally or unintentionally. (Sadly, this research into creating a bioweapon was financed with U.S. taxpayer money led by Anthony Fauci.)
