

AMENDMENT TO INTERGOVERNMENTAL AGREEMENT REGARDING STATE GANG TASK FORCE DETENTION LIAISON OFFICER (DLO) PROGRAM

This Amendment hereby modifies Intergovernmental Agreement (IGA), DPS Contract No. 2009-251/Pima County Contract No. 31176, between the State of Arizona through its Department of Public Safety, hereinafter referred to as "DPS", and the Pima County Sheriff's Office, hereinafter referred to as "Agency."

The sole purpose of this Amendment is to reflect an increase in personnel authorized to fill any and all vacancies in the program.

Section I. PARTICIPATION shall be amended to read as follows:

STATE OF ARIZONA

The Agency agrees to assign **two (2)** detention officers, herein referred to as "officers", to DPS on a full-time basis to perform the duties of Detention Liaison Officer (DLO) as delineated in Addendum "A" and for such assignments within the purposes of this IGA, as directed by DPS.

During this period of assignment, the Agency and DPS agree to allow said officers to maintain all benefits, rights, and privileges available to said officers as if they were assigned on a full-time basis to the Agency. The assigned officers must abide by all of the applicable rules and regulations of the Agency and is subject to its disciplinary process.

The Agency also agrees to enter into a Memorandum Of Understanding (MOU) with the Arizona Department of Public Safety relative to the connection and operation of the Arizona GangNet system.
