Title: Andrada Road Through Street

Introduction/Background:

The residential subdivision, Andrada Ranch Phase 2, is currently under construction off of Andrada Road between Wentworth Road and Davidson Road. The engineer for the development recommended the installation of an all-way stop at Andrada Road and Rincon View Drive as a result of limited sight distance at the two adjacent development roads. The all-way stop installation necessitates a modification to the existing Andrada Road through street ordinance. The through street ordinance modification should be considered in conjunction with the recommended Andrada Road and Rincon View Drive all-way stop ordinance.

Discussion:

Ordinance 2001-71 designates Andrada Road as a through street from the east line of Wentworth Road to the west line of Davidson Road. The recommended all-way stop installation at Andrada Road and Rincon View Drive will result in Andrada Road traffic stopping within the segment. The regulatory control for Andrada Road traffic necessitates a modification to the existing through street ordinance with a break at Rincon View Drive.

Conclusion:

Based on the recommended all-way stop installation at Andrada Road and Rincon View Drive, the Andrada Road through street ordinance is recommended to be updated with a break at Rincon View Drive.

Recommendation:

Ordinance 2001-71 be repealed and Andrada Road be designated a through street from the east line of Wentworth Road to the west line of Rincon View Drive, and from the east line of Rincon View Drive to the west line of Davidson Road.

AN ORDINANCE OF THE BOARD OF SUPERVISORS OF PIMA COUNTY, ARIZONA, ESTABLISHING ANDRADA ROAD AS A THROUGH STREET IN PIMA COUNTY, ARIZONA

THE BOARD OF SUPERVISORS OF PIMA COUNTY, ARIZONA FINDS THAT:

- 1. The Board of Supervisors of Pima County, Arizona has authority under A.R.S. §§ 28-627 and 28-855 to establish through streets and erect stop or yield signs.
- 2. The Board of Supervisors has determined that it is in the interest of public safety to establish Andrada Road as a through street in Pima County, Arizona.

BE IT ORDAINED BY THE BOARD OF SUPERVISORS OF PIMA COUNTY, ARIZONA:

SECTION 1. Andrada Road be designated a through street for the following limits:

<u>FROM</u> The east line of Wentworth Road The east line of Rincon View Drive <u>TO</u> The west line of Rincon View Drive The west line of Davidson Road

SECTION 2. Ordinance 2001-71 and all other ordinances or parts of ordinances in conflict herewith are superseded to the extent of such conflicts.

SECTION 3. This ordinance shall take into effect when and to the extent that stop signs or yield signs are posted on the intersecting streets.

SECTION 4. Violators of this ordinance shall be subject to civil or criminal sanctions as provided by law.

SECTION 5. The various county officers and employees are authorized and directed to perform all acts necessary or desirable to give effect to this ordinance.
