Housing Support Services – Pima County and Balance of State				

#### \*Purpose:

The funds will be used to support the Emergency Eviction Legal Services Emergency Housing program, which provides temporary, noncongregate shelter, ongoing case management, and other supportive services to individuals and families who have recently been evicted or are fleeing domestic violence and have nowhere to stay or who are otherwise homeless and unsheltered. The program, which began operation in January 2022, has had over 80% of clients exit to positive housing destinations. The Community & Workforce Development (CWD) department will use these grant funds to provide Emergency Shelter beds for program clients.

Indirect cost: 10%

#### \*Procurement Method:

Not applicable to grant awards.

#### \*Program Goals/Predicted Outcomes:

To provide Emergency Shelter beds and ongoing case management for homeless individuals and families through the Emergency Eviction Legal Services Emergency Housing program.

#### \*Public Benefit:

Funds will prevent homelessness for Pima County households at risk of eviction and homelessness.

#### \*Metrics Available to Measure Performance:

Program data as recorded in the Homeless Management Information System (HMIS).

### \*Retroactive:

Yes. The county received the letter of acceptance from ADES on 6/20/23. The next available Board of Supervisors' meeting to place the grant award on is 7/25/2023. However, none of these grant funds will be expended before Board approval. The negative impact of not approving these funds is individuals and families experiencing homelessness in Pima County may not receive emergency shelter and case management services.
