Requested Board Meeting Date: April 19, 2016

Title: Temporary Road Closure Resolution

Introduction/Background:

The Pima County Department of Transporation is requesting the closure of portions of Wilmot Road between Andrada Road and Old Vail Connection Road for the construction of a new two lane asphalt road.

Discussion:

As a result of the Pima County Traffic Engineering Division's traffic project plan review, road closures, including potential detour routes if needed, are recommended to facilitate smooth movement of traffic, reduction of project timeline, and reduction of construction costs of the roadway. Traffic Engineering held a public open house to present the closure plan and assess impacts to the public. Sahuarita School District, Vail School District, Rural Metro Fire, and the Prison Complex Administration were consulted and there was no opposition to the plan.

Conclusion:

Pima County Traffic Engineering recommends the closure of portions of Wilmot Road between Andrada Road and Old Vail Connection Road for the construction of a new two lane asphalt road to facilitate smooth movement of traffic and reduce construction costs of the new roadway. There was no known opposition at the public meeting for the closure.

Recommendation:

Staff recommends approval of this resolution to close portions of Wilmot Road between Andrada Road and Old Vail Connection Road for the construction of a new two lane asphalt road between July 1, 2016 and April 1, 2017.

Fiscal Impact:

Reduction in project costs.

RESOLUTION OF THE PIMA COUNTY BOARD OF SUPERVISORS PERMITTING THE TEMPORARY CLOSURE OF PORTIONS OF WILMOT ROAD IN PIMA COUNTY, ARIZONA, FOR THE CONSTRUCTION OF A NEW TWO LANE ASPHALT ROAD BETWEEN JULY 1, 2016 AND APRIL 1, 2017

WHEREAS, Pima County Department of Transportation is constructing a new two lane asphalt road to replace the existing dirt road on Wilmot Road from Sahuarita Road to a point 7.1 miles north of this intersection, and

WHEREAS, Pima County Department of Transportation has requested the temporary closure of portions of Wilmot Road to facilitate this event, and

WHEREAS, the Pima County Board of Supervisors has determined that it will be necessary to permit the temporary closure of portions of Wilmot Road to support this event,

THEREFORE, IT IS HEREBY RESOLVED by the Board of Supervisors of Pima County, Arizona, that:

SECTION 1. Portions of Wilmot Road between Andrada Road and Old Vail Connection Road shall be temporarily closed to public traffic on July 1, 2016 to April 1, 2017.

SECTION 2. All applicable County officers and employees are hereby authorized and directed to perform all acts necessary or desirable to give effect to this Resolution.
