ITEM SUMMARY, JUSTIFICATION and/or SPECIAL CONSIDERATIONS:

ORDINANCE NO. 2013 - ____, An ordinance of the Pima County Board of Supervisors establishing an abutting school crosswalk on Lodge Road in Pima County, Arizona. Staff recommends **APPROVAL**. (District 1)

The reason for the ordinance is to establish a 15 mph School Crosswalk Zone on Lodge Road for Fruchthendler Elementary School and to provide a safe pathway for school children crossing Lodge Road. A traffic study conducted by the Pima County Department of Transportation Traffic Engineering Division recommends the installation of the school crosswalk.

The guideline for establishing the school crosswalk meets the requirements set by the Arizona Revised Statutes regarding 15 mph School Crosswalk Zones.

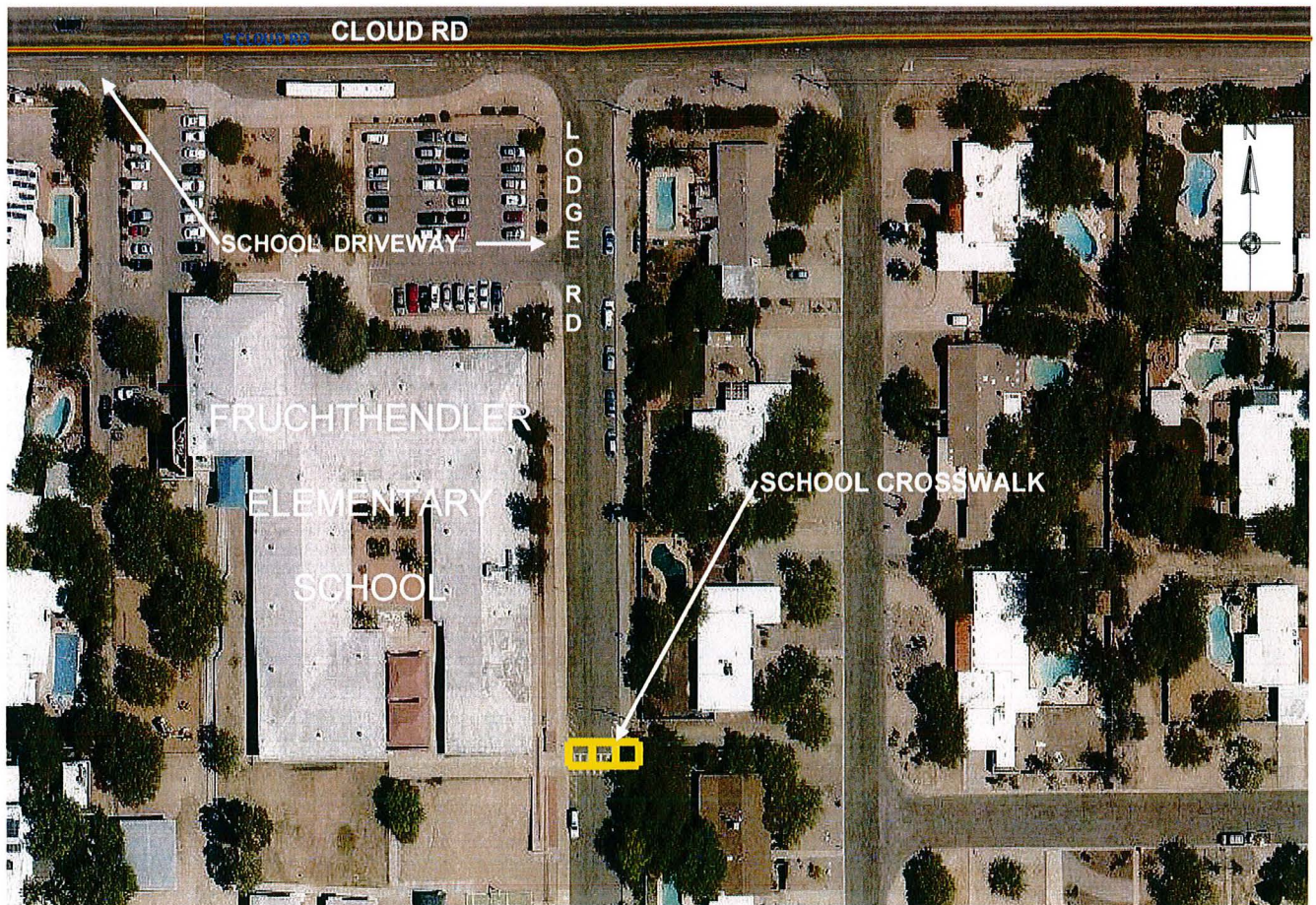

ORDINANCE NO. 2013-

**AN ORDINANCE OF THE PIMA COUNTY BOARD OF
SUPERVISORS ESTABLISHING AN ABUTTING SCHOOL
CROSSWALK ON LODGE ROAD IN PIMA COUNTY, ARIZONA**

WHEREAS, the Board of Supervisors of Pima County, Arizona, has the authority under Title 28 of the Arizona Revised Statutes, more specifically Sections 28-627 and 28-797 as amended, to establish abutting school crosswalks, and

WHEREAS, The Superintendent of Tucson Unified School District has advised the Board of Supervisors that an abutting school crosswalk should be established on Lodge Road 400 feet south of Cloud Road for Fruchthendler Elementary School, and

WHEREAS, the Superintendent of Tucson Unified School District has furnished written assurance to Pima County that crossing guards will be maintained by the School District during school hours at the crosswalk location,

THEREFORE, IT IS HEREBY ORDAINED by the Board of Supervisors of Pima County, Arizona, that:

SECTION 1. An abutting school crosswalk is hereby authorized for Lodge Road 400 feet south of Cloud Road for Fruchthendler Elementary School.

SECTION 2. All other ordinances or parts of ordinances in conflict herewith are superseded to the extent of such conflict.

SECTION 3. This ordinance shall take effect when the school crosswalk is installed and to the extent that portable signs are placed within the highway indicating that school is in session.

SECTION 4. Violators of this ordinance shall be subject to civil or criminal sanctions as provided by law.

SECTION 5. The various county officers and employees are authorized and directed to perform all acts necessary or desirable to give effect to this ordinance.


