Re: Agenda Items #20, 21, and 22: Grants Management and Innovation.

I DO NOT CONSENT TO SPEND MY TAXES ON THESE!

#20: Pima County takes a federal grant for another \$3,296,550 (our tax money) to go to the Catholic Community Services of Southern Arizona, Inc., to provide for food and shelter to benefit the illegal border crossers and extending the contract term to 12/31/23.

#21: Pima County takes a federal grant for \$4,177,000 (our tax money) City of Tucson/Pima Co. for food and shelter to benefit illegal border crossers, extending contract terms to 12/31/23.

#22: Pima Co. takes a federal grant for \$67,574 (our tax money) for The Inn of Southern Arizona, Inc., for emergency food & shelter to benefit illegal border crossers, extending contract term to 12/31/23.

Greetings Pima County Board of Supervisors,

In the past, I have called you out and warned you many times about your continued reliance on federal grants. When you accept federal grant dollars there are always strings attached. You are voluntarily relinquishing local jurisdiction for federal control and laws.
