#### SOUTHWEST LIBRARY LEASE AMENDMENT Four (4)

- 1. **DEFINED TERMS**. For purposes of this Amendment, the following terms have the meanings set forth below:
  - 1.1. Landlord. Tucson Unified School District #1, a political subdivision of the State of Arizona.
  - 1.2. Tenant. Pima County Library District, a political subdivision of the State of Arizona.
  - 1.3. Leased Premises. Approximately 2,270 square feet of space in the Southwest Education Center located at 6855 S. Mark Road in Tucson, Arizona, (the "Building").
  - 1.4. <u>Lease</u>. The original Lease executed on August 7, 2001 and the First Amendment dated October 1, 2005, Second Amendment dated December 7, 2010, Third Amendment dated December 15, 2015.
  - 1.5. Effective Date of this Amendment: June 30, 2020.

#### 2. BACKGROUND.

2.1. Tenant and Landlord entered into an original Lease agreement that provided a renewal option in Article XVIII for up to six (6) additional periods of four (4) years and eleven (11) months each to extend the Lease Term. The Tenant has exercised three (3) options and now wishes to exercise the fourth option.

- 3. **MODIFICATION OF LEASE**. Landlord and Tenant desire to modify the Lease and acknowledge the exercising of the Tenant's fourth (4<sup>th</sup>) renewal option as follows:
  - 3.1. Extended Lease Term. The Term of the Lease is hereby extended from July 1, 2020 through May 31, 2025.
  - 3.2. Basic Rent Schedule. The Basic Rent during the Extension Period is:
