

**RESOLUTION OF THE PIMA COUNTY BOARD OF SUPERVISORS PERMITTING THE TEMPORARY CLOSURE OF STREET SEGMENTS IN AJO, ARIZONA, FOR 4<sup>TH</sup> OF JULY PARADE ON FRIDAY, JULY 4, 2014**

**WHEREAS**, The American Legion Post 10 is conducting a parade event to celebrate the 4<sup>th</sup> of July in Ajo, Arizona, and

**WHEREAS**, The American Legion Post 10 has requested the temporary closure of certain Pima County roadway segments that intersect with 2<sup>nd</sup> Avenue, Solana Avenue, Pizal Street and Taladro Street, which are the jurisdiction of the Arizona Department of Transportation, on Friday, July 4, 2014, from 8:00 A.M. to 9:00 A.M. to facilitate this event, and

**WHEREAS**, the Pima County Board of Supervisors has determined that it will be necessary to permit the temporary closure of Hoover Street, Sahuaro Street, Montecito Street, Perro de Nieve Street, Tecolote Street, Cunada Street, Telera Street, Tonelada Street, Malacate Street, Pajaro Street, Rocalla Avenue, Plaza Street 67929, Morondo Avenue, from Malacate Street to Pizal Street, Plaza Street 66976, and Lomita Avenue to support this event,

**THEREFORE, IT IS HEREBY RESOLVED** by the Board of Supervisors of Pima County, Arizona, that:

**SECTION 1.** Hoover Street, from Cameron Avenue to Sahuaro Street, Pajaro Street, from Pizal Street to 200' East of Pizal Street, Plaza Street 67929, from Pizal Street to 350' East of Pizal Street, Plaza Street 66976, from Taladro Street to 350' East of Taladro Street, Solana Avenue at Sahuaro Street, Montecito Street, Perro De Nieve Street, Tecolote Street, Cunada Street, Telera Street and Malacate Street, Pizal Street at Rocalla Avenue and Morondo Avenue, Lomita Avenue at Pizal Street/Taladro Street, shall be closed to public traffic from 8:00 A.M. to 9:00 A.M during the Ajo 4<sup>th</sup> of July Parade on Friday, July 4, 2014.

**SECTION 2.** All applicable County officers and employees are hereby authorized and directed to perform all acts necessary or desirable to give effect to this Resolution.
