**A RESOLUTION OF THE PIMA COUNTY BOARD OF SUPERVISORS,
AUTHORIZING THE NAMING OF BASEBALL FIELD NUMBER TWO IN
WINSTON REYNOLDS MANZANITA PARK FOR JAZELLE ARMENTA**

WHEREAS, on September 18, 2019, 7-year-old Jazelle Armenta was on her way to cheerleading practice on Field Number Two of Winston Reynolds Manzanita Park when the vehicle in which she was riding was in traffic accident that resulted in her untimely death, and

WHEREAS, Jazelle's friends and family remember her as a "fearless and selfless" girl who "always made everyone smile," and

WHEREAS, Jazelle cheered for the Tucson Redskins football team, which also practices on Field Number Two at Winston Reynolds Manzanita Park, and

WHEREAS, the Tucson Redskins and the San Xavier Little League have been paying standard fees to share this field at Winston Reynolds Manzanita Park for more than 10 years, and

WHEREAS, parents, officials of the Redskins and the San Xavier Little League and nearby community residents have requested that this field be named for Jazelle, and

WHEREAS, the Natural Resources, Parks and Recreation Advisory Committee, on November 8, 2019, voted unanimously to recommend that the Board of Supervisors name this field for Jazelle Armenta,

NOW, THEREFORE, BE IT RESOLVED that:

1. The baseball Field Number Two in Winston Reynolds Manzanita Park is hereby named "Jazelle Armenta Field."
2. The Director of the Natural Resources, Parks and Recreation Department is authorized and directed to take all actions necessary to give effect to this resolution, including the installation of appropriate signage as necessary, updating maps and publications as appropriate, and advising the media and the community of the renaming and the reasons for this action.


