ITEM SUMMARY, JUSTIFICATION &/or SPECIAL CONSIDERATIONS:

The Arizona Early Childhood Development and Health Board (First Things First) has contracted the Pima County Health Department to provide an Oral Health Grant Program for the South Pima Regional Partnership Council, targeting low income and underserved young children with oral health screenings and fluoride varnishes and providing education on oral health to caregivers, pregnant women, and dental and medical providers.

Amendment 1 adds one year to the term of the grant and funds the additional year's activities by adding \$224,981.



IMPACT:
