

AMENDMENT ONE

1. BACKGROUND AND PURPOSE.

- 1.1. **Background.** Pima County (“County”) and Goodwill Industries of Southern Arizona, Inc. (“Contractor”), entered into the above-referenced contract to provide workforce development services to Pima County youth.
- 1.2. **Purpose.** County operates a workforce development program at Pima County ARIZONA@WORK (an American Job Center, formerly the Pima County One Stop).
 - 1.2.1. County finds that it is in the best interests of the Pima County residents to continue to provide workforce development services to at-risk youth.
 - 1.2.2. County has reviewed Contractor’s performance of the services and finds it satisfactory.

2. TERM AND EXTENSIONS, SECTION 1.0. Pursuant to **paragraph 1.2**, County exercises the first of two (2) available Extension Options. This Agreement will terminate on **December 31, 2020**.

3. COMPENSATION AND PAYMENT, SECTION 3.0 is amended as follows:

- 3.1. **Paragraph 3.1** is amended to increase “the Maximum Allocated Amount”:

FROM: \$160,898.10

TO: \$310,888.29

- 3.2. **Paragraph 3.2** is deleted in its entirety and replaced with the following:

Payments will be made from Pima County General Funds as follows:

January 1 2020 – December 21, 2020	\$149,990.19

3.3. Paragraph 3.3 is deleted in its entirety and replaced with the following:

Unexpended funds allocated for a contract year will not be carried over into another contract year.

4. **ISRAEL BOYCOTT CERTIFICATION, SECTION 31.0** is deleted in its entirety and replaced with the following:

Pursuant to A.R.S. § 35-393.01, if Contractor engages in for-profit activity and has 10 or more employees, and if this Agreement has a value of \$100,000.00 or more, Contractor certifies it is not currently engaged in, and agrees for the duration of this Agreement to not engage in, a boycott of goods or services from Israel. This certification does not apply to a boycott prohibited by 50 U.S.C. § 4842 or a regulation issued pursuant to 50 U.S.C. § 4842.

5. **EXHIBIT A – SCOPE OF WORK** is amended as follows:

5.1. **PROGRAM ACTIVITIES – CONTRACTOR, SECTION 5.0, paragraph 5.1**, the table is deleted in its entirety and replaced with the following:
