My name is Amelia Decker, MD and I am a pediatrician at Tanque Verde Pediatrics. Since the beginning of the start of the 2021-2022 school year for the Vail School District, our practice has been inundated with sick visits. A small but increasingly significant percentage of these are Covid positive. A large and significant percentage are visits related to other illnesses with responsible parents who are trying to rule out Covid to help contain spread. The children that we are seeing with Covid are sicker. The strain that these sick visits are putting on our office and on our patients' families cannot be understated.

We know that masks decrease the risk of transmission of Covid as well as other viruses.
We know that in-person school continues to be the gold standard for our children.
We know that vaccines decrease illness severity and Covid hospitalizations.

Please support a mask mandate for children in schools. Please support a mandatory vaccination policy for all teachers and staff of county schools. We cannot continue at this pace. For the first time we are seeing Pediatric Intensive Care Units with teen-age Covid patients. Our clinics are seeing 150 patients per day or more. These small interventions can make a large impact. They will create a pressure release for our clinics and hospitals. They will keep our kids in-person for the school year. And more importantly, they will save lives. Thank you for your time.

I respectfully request that the Board of Supervisors does not pass the mandate in Item 4 in the Agenda.

I'm submitting the message below for inclusion in the public comment BoS Agenda 10th August, 2021. In response to Memorandum dated 30th July 2021 from County Administrator Huckleberry (linked [HERE](#) & Attached):

Back in 2006 I was consulting industry on FDA Class III implantable medical devices. We had a FDA approved pacemaker fail to pace an individual's activity. That individual died while mountain biking. The young man was one out of hundreds of thousands of individuals using our product. This was followed by a regulatory process and legal proceedings to *prove* our product was still safe for public use. The product was able to resume sales after safety concerns were completely satisfied.

The experimental therapies you are endorsing under the FDA's Emergency Use Authorization (EUA) are not FDA approved. Additionally, there are thousands of documented deaths in VEARS as well as EU Stats databases where product safety is in question. Questions the *experts developing these treatments* have yet to answer.

Administrator Huckelberry you are a bureaucrat. Your endorsement of experimental drugs and favorable treatment for those who use them is misplaced.

The EUA allows use of these experimental drugs *only under* informed consent. Informed consent exists when an individual is free of external pressure to make that choice. Even if external forces feel it is in *their interest* that an individual makes a certain choice; be it public interest, industry interest, or interest of government agencies such as you represent.

Under no circumstances are you to pressure, coerce, provide partial treatment, or exercise your authority (or authority of agencies under your auspice) to get individuals to use experimental drugs or endorse use of any medical treatments. These decisions are between an individual and the agency established with their medical provider of which you are not a party. Furthermore, you are not qualified for nor are you a party of the process for establishing safety and efficacy of the products you are endorsing.

I'm going to close by reminding you of our past. Government pushing medical experimentation is something history has judged as well as labelling people through

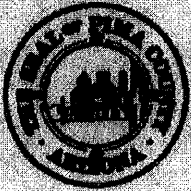
compelled dress. Would you suggest I wear a Star of David so you can know what *private* medical decisions I make; then pressure me to make the decisions you choose?

Excerpt from Nuremberg code:

"The voluntary consent of the human subject is absolutely essential. This means that the person involved should have legal capacity to give consent; should be so situated as to be able to exercise free power of choice, without the intervention of any element of force, fraud, deceit, duress, overreaching, or other ulterior form of constraint or coercion; and should have sufficient knowledge and comprehension of the elements of the subject matter involved as to enable him to make an understanding and enlightened decision. This latter element requires that before the acceptance of an affirmative decision by the experimental subject there should be made known to him the nature, duration, and purpose of the experiment; the method and means by which it is to be conducted; all inconveniences and hazards reasonably to be expected; and the effects upon his health or person which may possibly come from his participation in the experiment. The duty and responsibility for ascertaining the quality of the consent rests upon each individual who initiates, directs, or engages in the experiment. It is a personal duty and responsibility which may not be delegated to another with impunity."

MEMORANDUM

Re: **Ability of Pima County through our Public Health Agency to Require Masks for Students in the K-12 System and in Particular for those Students under the age of 12 who are not yet Eligible to be Vaccinated**

I have provided each Board Member with a copy of an Attorney-Client Privilege document dealing with the County's ability to issue a Public Health directive requiring masks for K-12 students, faculty and staff. Please note an addition to this communication relating to effective date.

This legislation is an example of laws passed by the Legislature and enacted into law by the Governor without public or public health input. This language was a floor amendment to House Bill (H.B.) 2898 that occurred on June 25, 2021. It was introduced and passed by the House on that date without a single hearing, transmitted to the Senate on June 28, passed by the Senate on June 30, transmitted to the Governor and signed by the Governor on June 30. No hearings, no public discussion, no information was made available for public review regarding this amendment that has significant and potentially serious adverse public health outcome particularly for those younger than 12 years of age who cannot be vaccinated at this time.

This legislation endangers public health.

Greetings to the Board,

Please reconsider Mr. Huckleberry's proposal to mandate COVID vaccinations for all county employees. Huckleberry's intention to jump beyond a "wait and see" approach is quite a leap which interferes with each individual's right to make their own health decisions.

Huckleberry's memorandum points out there are "a number of public sectors in other states requiring employees to be vaccinated, including public employees". What he doesn't include in the memo are all the existing lawsuits against similar measures in many other states. States such as Arkansas and Montana (among others) have successfully declared employers cannot mandate employees to be vaccinated.

Huckleberry goes on; health care providers (i.e. Banner Health) require its employees to be vaccinated; this is sensible since they directly deal with the public (although they should still have a choice). However, there are numerous county departments that are not part of the health care sector that do not interact directly with the public; those employees work from their cubicles and offices.

Huckleberry's concern about the delivery of direct services to the public and the risks to those being served has no muster. Are not the requirements of wearing a mask and social distancing still in effect and are not the safety dividers still up? The number of employees not vaccinated outnumbers those who have been for the simple reason - they choose not to get the COVID vaccination. These same employees have continued to practice all the safety measures; wearing masks, social distancing, staying home when ill, and regularly washing their hands.

As an employee who has been with the county for sixteen years I implore the board to read again, very carefully, the director of human resources response (all the factors and consequences concerning the mandate) and dismiss Huckleberry's recommendation and continue the discussion to seek a more reasonable, practical approach to this very difficult and divisive situation. 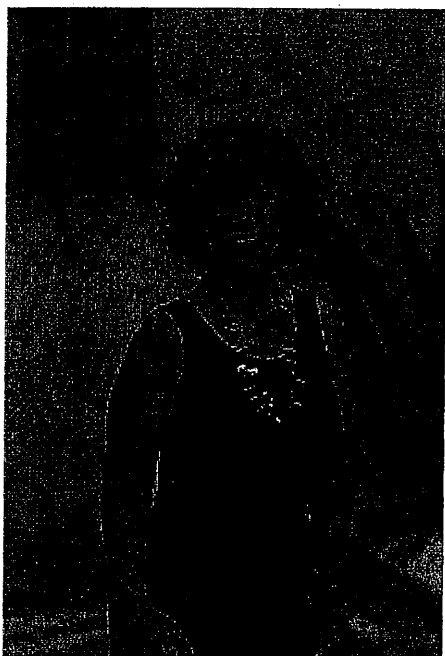

I urge the Board of Supervisors to vote "NO" on the mandatory COVID-19 vaccinations for County employees. Director Bohland's memo (attached to County Administrator Huckelberry's memo dated August 10, 2021) stated that, ***"of the approximately 6,800 employees ... we know for certain that 2,046 employees have been vaccinated...."*** What Director Bohland is saying is that only one-third of county employees appear to have been vaccinated; two thirds opted not to vaccinate. What is that telling you? When I first heard that statistic regarding the number of unvaccinated Pima County employees (4,754 unvaccinated employees out of a total 6,800 employees), I was shocked. As a recent retired Pima County employee, I know the extensive outreach efforts conducted by county administration to encourage county employees to get vaccinated. Yet, and apparently, to no avail for the 4,754 employees who have chosen not to get vaccinated. County Administrator Huckelberry's recommended mandate is that all employees be required to accept the COVID-19 vaccination as a condition to continued employment. As a retired Pima County employee, I find this recommendation egregious and a violation of a person's First Amendment rights—and apparently the 4,754 Pima County employees who are not vaccinated have their reasons, too. Listen to what your employees are telling you.

As a retired Pima County employee, I would like to inform you about what happened to a former Pima County employee and her decision to receive the COVID injection. This employee (while employed at Pima County) received her first Moderna injection on a Monday and by the following Wednesday night/Thursday morning, she was dead (her family has provided approval to provide you this information). The point to make here is not whether the Moderna injection had a direct/indirect causal effect to her death, but rather the fact that she made the decision to get COVID injected. Again, it was her choice. However, with the proposed mandate requiring employees to receive the COVID injection as a condition to continued employment, they are left with virtually no ability to choose—take the COVID injection or lose your job, pension, benefits, and livelihood. Is the county prepared to accept liability for any death, disability, and/or other complication resulting from the mandated COVID vaccination? When an individual receives the COVID injection, they are required to sign a statement informing them of the dangers, complications, etc., that could occur post-COVID injection. However, when you mandate the injection as a condition of employment, you are forcing the employee to forego their right to make their own decision—they must sign the "waiver" to get the COVID injection, and to remain gainfully employed.

Asking for an exemption can also be a losing battle for a county employee. I have first-hand knowledge what happens when Pima County employees obtain a medical exemption from their physician and request an exemption to wearing a face mask. In fact, the employee asked instead to use a face shield—only to end up in a contentious battle with management—no one dare challenge the director's authority in asking for an exemption. Human Resources representative(s) added to the employee's dilemma by first agreeing to the use of the face shield, but then changing their position stating that "only face masks were approved by the Board of Supervisors—not face shields." Do you understand the ramifications when you make these broad sweeping policies that really do not allow for exemptions? Medical exemptions may work with some directors and Human Resources staff, but there are some who

will not work with the employee—that is an undisputed fact in my experience at Pima County. And the same will undoubtedly hold true for the mandated COVID-injection exemption requests. Are you prepared to deal with this?

Furthermore, the County Administrator's recommendation does not provide for any type of exemption (refer to CHH memo dated August 10, 2021). Following Director Bohland's information provided in her memo, are you prepared to cover the cost of "reasonable accommodation of regular COVID-19 testing" should exemptions be allowed in your recommendation? Let's take, for example, of the 4,754 employees who are currently not vaccinated, 50% will ask for an accommodation (this is a reasonable amount for this hypothetical exercise). Testing of those individuals (2,000) will range from \$85-\$95 per test which equates to \$170,000 to \$190,000 per group testing. And let's say that testing continues for at least six months; testing twice per week that figure could amount to over \$8 million dollars required for six months of group testing. Is that what you are approving with this recommendation? Of course, this is assuming that 2,000 employees will agree to accept the COVID injection—which they have not to date.

Thus, are you holding Pima County employees hostage to accept the injection or lose their job? Why do you not take the same stance on undocumented individuals who are COVID positive and entering Pima County or residing in Pima County owned properties such as the Curley School Gymnasium in Ajo, Arizona (refer to Consent Calendar item #10 - for which you are requesting COVID funds for capital investment "to repair and modify [the property] to meet pandemic operations needs including but not limited to temporary shelter for asylum seekers"). Why do you allow possible COVID positive individuals to enter a Pima County owned property, yet threaten your Pima County employees with loss of job should they refuse the COVID injection? Is that not only hypocritical, but also biased and possibly rendering each supervisor derelict of duty to preserve the health and safety of Pima County residents at-large?

In summary, I urge you to vote "NO" to any recommendation requiring Pima County employees to receive the COVID injection **as a condition to continued employment.**

To do otherwise is nothing more than **sanctioned institutional abuse.**

Your concerns about public safety are better saved for the theatre. I contacted Human Resources regarding my difficulties with the mask mandate. The Human Resource agent was understanding and provided me with a face shield to wear instead of a mask. Please note that I had my own office, with no public contact, and a limited amount of contact with other employees. The face shield accommodation infuriated Director Regina Kelly, who contacted Human Resources to voice her disapproval. Before I received notification from Human Resources informing me that the agreed upon accommodation was no longer acceptable, Director Kelly informed me that I was required to wear a mask or obtain a medical exemption, and I could not return to work without one or the other. I obtained a medical exemption, which further infuriated Director Kelly. It was then determined that I should telecommute. Due to unrelenting internet connectivity issues, lack of a printer, and excessive deadlines, I had to return to the office to complete my work. After several months, it was determined that I would be forced to take a furlough using several weeks of vacation. The Sunday before returning to work, I received a telephone call from a former supervisor informing me that I would be reporting to a her in a lateral position. I was placed on furlough because the County was trying to reduce the spread of COVID within the County buildings. Interestingly, in my department only the employees that had vacation time saved were placed on furlough. When I returned to work, I was required to leave a private office and work in a floor of open cubicles. The floor that I left was completely abandoned. Concerns for my health or well being were never considered. I gave a two week notice to terminate my employment shortly thereafter. As you see, the exemption process that you propose has the potential to be determined by personal bias, and there will be no recourse for retaliatory behavior.

Introduction

The judgment by the war crimes tribunal at Nuremberg laid down 10 standards to which physicians must conform when carrying out experiments on human subjects in a new code that is now accepted worldwide.

This judgment established a new standard of ethical medical behaviour for the post World War II human rights era. Amongst other requirements, this document enunciates the requirement of *voluntary informed consent* of the human subject. The principle of voluntary informed consent protects the right of the individual to control his own body.

This code also recognizes that the risk must be weighed against the expected benefit, and that unnecessary pain and suffering must be avoided.

This code recognizes that doctors should avoid actions that injure human patients.

The principles established by this code for medical practice now have been extended into general codes of medical ethics.

The Nuremberg Code (1947)

Permissible Medical Experiments

The great weight of the evidence before us to effect that certain types of medical experiments on human beings, when kept within reasonably well-defined bounds, conform to the ethics of the medical profession generally. The protagonists of the practice of human experimentation justify their views on the basis that such experiments yield results for the good of society that are unprocurable by other methods or means of study. All agree, however, that certain basic principles must be observed in order to satisfy moral, ethical and legal concepts:

1. The voluntary consent of the human subject is absolutely essential. This means that the person involved should have legal capacity to give consent; should be so situated as to be able to exercise free power of choice, without the intervention of any element of force, fraud, deceit, duress, overreaching, or other ulterior form of constraint or coercion; and should have sufficient knowledge and comprehension of the elements of the subject matter involved as to enable him to make an understanding and enlightened decision. This latter element requires that before the acceptance of an affirmative decision by the experimental subject there should be made known to him the nature, duration, and purpose of the experiment; the method and means by which it is to be conducted; all inconveniences and hazards reasonably to be expected; and the effects upon his health or person which may possibly come from his participation in the experiment.

The duty and responsibility for ascertaining the quality of the consent rests upon each individual who initiates, directs, or engages in the experiment. It is

a personal duty and responsibility which may not be delegated to another with impunity.

2. The experiment should be such as to yield fruitful results for the good of society, unprocurable by other methods or means of study, and not random and unnecessary in nature.
3. The experiment should be so designed and based on the results of animal experimentation and a knowledge of the natural history of the disease or other problem under study that the anticipated results justify the performance of the experiment.
4. The experiment should be so conducted as to avoid all unnecessary physical and mental suffering and injury.
5. No experiment should be conducted where there is an a priori reason to believe that death or disabling injury will occur; except, perhaps, in those experiments where the experimental physicians also serve as subjects.
6. The degree of risk to be taken should never exceed that determined by the humanitarian importance of the problem to be solved by the experiment.
7. Proper preparations should be made and adequate facilities provided to protect the experimental subject against even remote possibilities of injury, disability or death.
8. The experiment should be conducted only by scientifically qualified persons. The highest degree of skill and care should be required through all stages of the experiment of those who conduct or engage in the experiment.
9. During the course of the experiment the human subject should be at liberty to bring the experiment to an end if he has reached the physical or mental state where continuation of the experiment seems to him to be impossible.
10. During the course of the experiment the scientist in charge must be prepared to terminate the experiment at any stage, if he has probable cause to believe, in the exercise of the good faith, superior skill and careful judgment required of him, that a continuation of the experiment is likely to result in injury, disability, or death to the experimental subject.
