SUBAWARD AMENDMENT

WHEREAS, DISTRICT previously made a Subaward under a United States Environmental Protection Agency (EPA) Grant for WETLANDS PROTECTION DEVELOPMENT – Lower Santa Cruz River (the PROJECT) to the SUBAWARDEE, as referenced above, dated December 1, 2012; and




