I have reviewed the agenda for Tuesday's meeting and find some of the 2024 Broad Legislative Goals that you are planning to adopt in Resolution 2023-36 questionable.

Section 2, A: Protect the Pima County Taxpayer:

You did not protect us, the taxpayers, when you have voted for spending many millions of dollars on supporting illegal immigrants or when you voted for approving a battery factory that DAILY use SIX swimming pool sized amounts of water or when you voted on raising our taxes or...... How can we trust that what you outline in this section is for our "protection" when so much of what you vote for encumbers us?

Section 2, **A**, **2**: Create reasonable boundaries around public record requests while maintaining a high level of transparency and accountability:

Section 2, D: Fortify Public Safety
