### \*Introduction/Background:

Approval by the Board of Supervisors to accept the Designation of Public Right of Way of a portion of River Road.

#### \*Discussion:

The purpose of this document is to clarify the intended use of the property described in Resolution and Order No. 2024-63 and Establishment Proceedings No. 3039, which was acquired for a portion of River Road lying within Section 15 Township 13 South, Range 13 East. The execution and recordation of this document by Pima County, a political subdivision of the State of Arizona, will serve to designate this property as a public road right-of-way for the County highway purposes.

#### \*Conclusion:

The Department of Transportation will accept the Designation of Public Right of Way into the County highway system.

### \*Recommendation:

The Department of Transportation recommends that the Board of Surpervisors approve and authorize the Chair to execute the Designation of Public Road Right of Way.

### \*Fiscal Impact:

Funding and maintenance on this roadway would come from the Department of Transportation operating funds.

### RESOLUTION AND ORDER NO. 2024- 63

A RESOLUTION AND ORDER OF THE BOARD OF SUPERVISORS OF PIMA COUNTY, ARIZONA, PROVIDING FOR THE ESTABLISHMENT OF A PORTION OF RIVER ROAD, A COUNTY HIGHWAY SITUATED WITHIN THE SOUTHEAST QUARTER OF SECTION 15, TOWNSHIP 13 SOUTH, RANGE 13 EAST, GILA AND SALT RIVER MERIDIAN, PIMA COUNTY, ARIZONA.

### **UNDER PROCEEDING NO. 3039**

### The Board of Supervisors of Pima County, Arizona finds:

- 1. The Pima County Engineer ("County Engineer") has requested that the Pima County Board of Supervisors (the "Board") establish a county highway to be known as River Road, located within a portion of the southeast quarter of Section 15, Township 13 South, Range 13 East, Pima County, Arizona, pursuant to A.R.S. § 28-6701(B), said road being more fully described in attached Exhibit "A". Also included is the referenced right-of-way plan for project 4BFALC in attached Exhibit "B".
- 2. The County Engineer filed a report and map of the proposed highway with the Board in accordance with A.R.S. § 28-6702(A)(1).
- 3. Said petition for establishment was set for a hearing before the Board on November 19th, 2024, in accordance with A.R.S. § 28-6703.
- 4. Notice of the hearing was published once a week for two consecutive weeks in a newspaper of general circulation prior to the hearing,

5. At the hearing on the 19th day of November 2024, the Board considered the feasibility, advantages and necessity of the highway sought to be established and determined the proposed highway to be a public necessity.

### NOW, THEREFORE, BE IT RESOLVED THAT:

- 1. The Board hereby establishes the public roadway described in the attached Exhibit "A" and commonly referred to as River Road as a county highway.
- 2. The Clerk of the Board is hereby directed to record this Resolution and Order, together with a map of said highway, as Establishment Proceeding No. 3039 in the Office of the Pima County Recorder, Pima County, Arizona.
- 3. The appropriate County officers and employees are hereby authorized and directed to perform all acts necessary and desirable to give effect to this Resolution.






