4. CALL TO THE PUBLIC

Joann Schultz, Reid Park Zoological Society, spoke in support of the 2015 Bond Election and the zoo project.

Lou Sampson, encouraged the Board to discontinue the current practice of discretionary spending.

Geri Ottoboni addressed the Board about the County Administrator's discretionary spending proposal.

Richard Hernandez spoke on his commitment to the Sunnyside community and suggested resolutions to the Board for the new year.

5. CONVENE TO EXECUTIVE SESSION

It was moved by Supervisor Elías, seconded by Supervisor Valadez and unanimously carried by a 5-0 vote, to convene to Executive Session at 9:32 a.m.

6. **RECONVENE**

The meeting reconvened at 10:03 a.m. All members were present.

EXECUTIVE SESSION

7. Pursuant to A.R.S. §38-431.03(A) (3) and (4), for legal advice and direction regarding a proposed settlement of Valencia Kolb Properties, L.L.C., et al. v. Pima County, United States District Court Case No. 4:13-CV-01319-DCB.

Chris Straub, Chief Civil Deputy County Attorney, stated the case concerned Valencia Kolb Properties, L.L.C., et al. v. Pima County, United States District Court Case No. 4:13-CV-01319-DCB, which alleged that the Plaintiffs were damaged by Pima County's actions related to the alignment of and planned improvements to the Valencia Kolb intersection. He explained that in November 2014, the Court dismissed eight of the nine counts in the Plaintiffs' complaint and the Plaintiffs have offered to dismiss the action in its entirety in a manner consistent with the Court's ruling. The County Attorney's Office sought authority to proceed as discussed in Executive Session and recommended the Chair be authorized to execute a settlement agreement on behalf of Pima County.

It was moved by Supervisor Elías, seconded by Supervisor Valadez and unanimously carried by a 5-0 vote, to proceed as discussed in executive session and accept the recommendation.

8. Pursuant to A.R.S. §38-431.03(A) (3) and (4), for legal advice and direction regarding the following consolidated cases: C.H.H. Tucson Partnership, L.P. v. Pima County and El Conquistador M.A.H. II, L.L.C. v. Pima County, Arizona Tax Court Consolidated Case Nos. TX2010-001421, TX2011-000379, TX2011-000380, and TX2013-000155.

Chris Straub, Chief Civil Deputy County Attorney, stated the case pertained to C.H.H. Tucson Partnership, L.P. v. Pima County and El Conquistador M.A.H. II, L.L.C. v. Pima County, Arizona Tax Court Consolidated Case Nos. TX2010-001421, TX2011-000379, TX2011-000380, and TX2013-000155 involving the El Conquistador Resort, adjoining property and a country club. The County Attorney's Office sought authority to proceed as discussed in Executive Session.

It was moved by Supervisor Elías, seconded by Supervisor Valadez and unanimously carried by a 5-0 vote, to proceed as discussed in executive session.

COUNTY ADMINISTRATOR

9. The Board of Supervisors on December 9 and 16, 2014, continued the following:

Board of Supervisors Policy

Staff requests approval of the Board of Supervisors Policy regarding Budget Development Transparency and Transfer to Community Nonprofit Organizations for Public Services, as follows:

- A. Approval of Board of Supervisors Policy E36.1, Outside Agency Funding, to replace the current policy entitled Review of Requests and Monitoring of Contracts for Discretionary Funds Allocated to Outside Agencies for Economic Development, Health and Social Services;
- B. Selection or rejection of the Small Public Purpose Grants
Option(s):
 - 1. Outside Agency Subaccount
 - 2. Board Member Allocations and the approval of the Board of Supervisors Policy E36.2, Small Public Purpose Grants
 - 3. Discontinuation
- C. Approval of the amendment to the Board of Supervisors Policy D29.4, Pima County Contracts Policy

Supervisor Valadez stated that in regards to this issue, he did not believe anything inappropriate had happened and disagreed with the opinion of the Goldwater Institute, but he acknowledged that greater transparency was needed. He explained he could not support any of the options outlined by the County Administrator in their entirety. The proposed options were not considered.

It was moved by Supervisor Valadez and seconded by Supervisor Carroll to: 1) prohibit the current policy of using monies from Board budgets for discretionary expenditures; 2) effective immediately, all Contingency Fund requests for social service agencies go to the Outside Agency Review Committee for the purpose of determining whether or not they fit within the County's priorities and concurrently that they be reviewed by the County Attorney's Office to ensure they meet legal parameters; and 3) to direct the County Administrator during the 2015/16 budget, to develop a process for the approval of small grants to social service agencies in an open and transparent manner. No vote was taken at this time.

Supervisor Carroll credited the Goldwater Institute for their efforts to promote more transparency in government.

Supervisor Miller expressed her opinion that these expenditures violated the Arizona gift clause and noted that this opinion was shared by the Goldwater Institute and her personal attorney. She stated no other counties made these types of expenditures and doing this gave the appearance of impropriety. Supervisor Miller explained the two tests that must be met for grants of this nature. She added that the Contingency Fund was needed for unseen emergencies and should not be used for charitable donations.

Chair Bronson stated that in the past there had been no mechanism to process small dollar grants for small non-profit entities that did good things in the community and that this would create that process.

Supervisor Carroll explained that the Outside Agency Review Committee included one member appointed by each Supervisor and that their meetings were conducted in a public setting. He supported discontinuation of the current practice and based on his communication, felt the Goldwater Institute would be satisfied and withdraw related concerns.

Supervisor Elías expressed his support for the motion and transparency but disputed the idea that past donations had been made for political gain.

Chuck Huckelberry, County Administrator, clarified that the interim policy of placing certain expenditures made from the Supervisors' office budgets on the Agenda would be discontinued by this Board action.

Upon roll call, the motion carried unanimously by a 5-0 vote.
