Arizona Vehicle Theft Task Force

***Purpose:**

Assign a P.O.S.T. certified sworn law enforcement officer to the Arizona Vehicle Theft Task Force to enhance law enforcement services concerning vehicle theft through the cooperative efforts of the parties to this agreement. This Intergovernmental Agreement (IGA) Amendment is to extend the terms of the agreement for one year until 6/30/2025 and increase the funds.

***Procurement Method:**

The grant award amendment was reviewed and signed by PCAO.

***Program Goals/Predicted Outcomes:**

Enhance law enforcement services concerning vehicle theft through cooperative efforts of the agencies involved.

***Public Benefit:**

Collaborate with other area law enforcement agencies – state, local, and federal – to mitigate vehicle thefts in the State.

***Metrics Available to Measure Performance:**

Monthly reports.

Yes. Received the IGA Amendment from the Arizona Department of Public Safety on 6/19/24.
