

Dear Pima County Board of Supervisors,

My name is Karina Jurado, and I am a resident of Pima County. I am contacting you today with regard to the impacts of the Reconciliation Package (HR 1) on our newest refugee neighbors. At a time when we should be focused on how to best integrate the newest members of our community, we are instead focused on how to ensure their survival given dramatic changes to critical lifeline services.

Refugees in Arizona are resilient- rebuilding their lives and strengthening our communities as they start small businesses, address food scarcity by starting community gardens, and help to meet critical workforce needs in healthcare and other sectors. The limited and temporary services that they receive upon arrival are a lifeline to stabilization and a safe and humane integration process.

I write today to ask that Pima County support the positive impact of refugees on our local communities and invest in programs that will ensure economic stability and prosperity for our entire community. I urge you to support:

- Emergency funding for community food banks to address immediate needs
- Emergency funding for refugee support programs that deliver trusted guidance, basic needs assistance and accredited legal services: Refugee serving organizations are a trusted source of information, basic needs coordination, and also are DOJ accredited to deliver immigration legal services but require support for rapid scaling and capacity building to meet the moment.
- Pima County to work with AZDES on English language, workforce and volunteer programs and AZDOT on state IDs/driver's license renewal to remove unnecessary barriers and streamline processes as outlined in the Addendum Agenda

I am a supporter of Catholic Community Services of Southern Arizona, who helps lawful permanent residents apply for U.S. citizenship through affordable naturalization services. We also offer free English and Citizenship/Civics classes in partnership with Pima Community College for those who qualify. Our goal is to guide and support individuals on their path to becoming proud United States citizens.

The people are core to the success of Arizona's economy, and the state thrives when we invest in the residents of our state. Please take action to ensure that refugees are

supported as valuable long-term members and contributors of our Pima County community.



My name is **Ilean Rivas**, and I am a resident of Pima County. I am writing to express my strong support for the County's consideration of emergency funding to assist refugees who are losing access to critical benefits due to changes in the Reconciliation Package (HR 1).

As the **daughter of immigrants**, this issue is deeply personal to me. My family came to this country seeking safety and opportunity, yet we never qualified for any public benefits. Growing up in poverty taught me firsthand the struggles many families face in trying to meet basic needs while striving to build a better future. Those experiences shaped my understanding of how vital community support and equitable access to resources can be.

Now, as a **single mother of three children**, one of whom has special needs, I know how quickly circumstances can become overwhelming when assistance is limited. The loss of SNAP benefits for newly arrived refugees will not only affect those families but also ripple through our local communities—impacting schools, employers, and service providers who care deeply about the well-being of every resident.

Refugees in Tucson and across Arizona are incredibly resilient. They start small businesses, fill critical workforce gaps, and enrich our neighborhoods with culture and compassion. To continue supporting their success and stability, I urge the Board to approve:

- Emergency funding for community food banks to address immediate food insecurity.
- Emergency funding for refugee support programs that provide legal guidance, case management, and essential basic needs assistance.
- Collaboration with AZDES and AZDOT to reduce barriers related to language access, employment readiness, and state identification renewals, as outlined in the Addendum Agenda.

I am a proud supporter of **Catholic Community Services of Southern Arizona (CCS)**, which helps refugees and lawful permanent residents achieve independence through affordable immigration legal services and free English and Citizenship classes. These programs truly change lives and strengthen the entire community.
