**Title:** Summit View Elementary School Abutting Crosswalk Ordinance

**Introduction/Background:**

This ordinance will establish an abutting school crosswalk across from Summit View Elementary School on Summit Street, 40 feet east of Vanessa Lane. The school crosswalk is to be installed as part of a development project on Summit Street.

**Discussion:**

A new abutting school crosswalk is to be installed as part of a plan to install a walkway on Summit Street that leads to Summit View Elementary School. The Pima County Traffic Engineering Division has reviewed and approved these plans for the walkway and the new school crosswalk location.

**Conclusion:**

As part of a Pima County Traffic Engineering Division approved plan to install a new walkway to Summit View Elementary School, a new school crosswalk is to be installed across Summit Street approximately 40 feet east of Vanessa Lane to allow school-aged pedestrians from the north side to cross Summit Street at a supervised and maintained school crosswalk and access the Summit View Elementary School property.

**Recommendation:**

Pima County Traffic Engineering Division recommends approval of this abutting school crosswalk Ordinance.

**ORDINANCE NO. 2016-\_\_**

**AN ORDINANCE OF THE PIMA COUNTY BOARD OF SUPERVISORS FOR INSTALLATION OF AN ABUTTING SCHOOL CROSSWALK ON SUMMIT STREET EAST OF VANESSA LANE IN PIMA COUNTY, ARIZONA**

**WHEREAS**, the Board of Supervisors of Pima County, Arizona, has the authority under Title 28 of the Arizona Revised Statutes, more specifically Sections 28-627 and 28-797A, as amended, to establish abutting school crosswalks, and

**WHEREAS**, that as part of the new walkway improvement plan as approved by the Pima County Traffic Engineering Division, an abutting school crosswalk will be established on Summit Street 40 feet east of Vanessa Lane,

**WHEREAS**, the Assistant Superintendent of the Sunnyside School District has furnished written assurance to the County that crossing guards will be maintained by the Sunnyside School District,

**THEREFORE, IT IS HEREBY ORDAINED** by the Board of Supervisors of Pima County, Arizona, that:

**SECTION 1.** An abutting school crosswalk is hereby established on Summit Street approximately 40 feet east of Vanessa Lane.

**SECTION 2.** Ordinance No. 1998-89 and all other ordinances or parts of ordinances in conflict herewith are superseded to the extent of such conflicts.

**SECTION 3.** The various county officers and employees are authorized and directed to perform all acts necessary or desirable to give effect to this ordinance.


