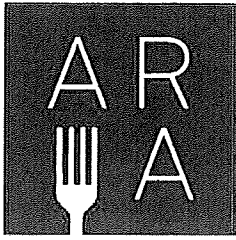

Dear Chairwoman Grijalva,

I am writing you today not only as a representative of Arizona's restaurant industry, but also as a former Maricopa County Supervisor of nearly ten years to express concerns with the proposal (agenda item #15) in front of the Pima County Board of Supervisors (BOS) to alter the process of placing items on the BOS agenda. Under the proposal, any potential agenda item proposed by a Supervisor would be subjected to a multi-prong review process before being accepted as an item and would severely curtail a Supervisor's ability to timely respond to their constituents.

One concern I have, and I'm not casting aspersions, is the ability of the Clerk of the Board to return items submitted by an elected Supervisor for being either "incomplete or inaccurate." This presents many issues and a potential opportunity for abuse. As currently drafted, the decision of completeness and accuracy is left solely to the interpretation of the Clerk. For example, if a submission was missing a period, or a comma was used instead of a semicolon, does that constitute inaccurate? If the fiscal impact section stated that there was uncertainty about the fiscal impact, does that constitute incomplete? These can be extreme cases but the point is the same, that not all issues will be easily identifiable in a clear cut manner... and the correct forum for drawing a conclusion is the Board of Supervisors.

The other potential consequence of the Clerk review of Supervisor submitted issues is the "bad actor." It is my sincere hope that this issue will never materialize, but when writing binding policies you must consider it. If the Clerk wanted to prevent an item from being placed on the agenda, all one would need to do is wait until the deadline for the agenda has passed and then return the item to the Supervisor and mark it as incomplete or inaccurate. The policy lacks any guardrails around the clerk review process such as: a standard time to review, substantive incompleteness/inaccuracy, or a review process to override the Clerk if a perceived error was made. Because of this, the ability of constituents to approach their elected Supervisor and have issues raised to the Board level could be severely restrained.

The second concern I have is the need for a legal review process prior to an item being placed on the agenda. Under the current draft policy, all items must be reviewed by legal counsel. However, it is unclear if the legal counsel can prevent an item from being placed on the agenda, make changes to the submission, or if the review is purely to allow the attorney to make comments. As a matter of practice, the County

Attorney's Office should be reviewing all action items on the Board of Supervisors agenda in order to answer any questions about the item that may come up during the meeting. If the policy is just meant to formalize this process, then it should be made clear in the policy that the attorney's ability or inability to timely review an item should not hinder the ability of the supervisor to place an item on the agenda. Additionally, a negative opinion of the attorney should not prevent an item from being discussed unless it is truly a violation.

My final concern is around the need for a detailed agenda item report to be filled out. If "completeness" and "accuracy" of this report may prevent an item from being placed on the agenda, then Supervisors may shy away from attempting to place an item on the agenda with limited information. In some instances, this may be a good thing by preventing unripe topics from taking up agenda space. However, in my experience, there have been several times that putting an item on the agenda led to good discussion amongst the Board about the best way to proceed to gather the relevant information and asking staff to report back on recommendations and allowing compliance with open meeting laws. Putting a barrier in place to prevent this can have profound negative consequences for the public seeking input from their elected officials.

Given the reasons detailed above, I would ask that the Board table this topic and allow for additional inputs from the community on how to best revise this policy, or if such a revision is even necessary. Thank you for your time and consideration and please let me know if I can be of further assistance.
