County Employees Appointed to Boards, Commissions and Committees

Background

The Board of Supervisors receives numerous recommendations and actions from appointed advisory boards, committees and commissions (BCCs). The primary purpose of these BCCs is to obtain public review and comment on proposed actions to be considered by the Board. These structures reflect public participation processes in local governance, and they are designed to accept and consider a broad range of opinions and values related to County governance.

The Board recently inquired whether there are any rules related to paid County employees holding Board-appointed positions on BCCs. There are no such rules relating to this matter.

The members of the Board-appointed BCCs all serve without compensation. Therefore, it is reasonable that if the Board desired to continue allowing County employees to sit on any BCC, a condition of appointment could be that the employee is required to use accrued vacation hours when serving in that role. Such would place the County employee on the same footing as a non-compensated volunteer when serving on a BCC. An exception to this requirement could be when the employee is an appropriate "subject matter expert" and the appointment to such a BCC is deemed part of the employee's job responsibilities.

Currently, the County has 58 Board-created BCCs with 601 seats. The BCC list, including membership, is attached. Of the 601 seats, 35 are held by 28 County employees. Five of the 28 employees are Board of Supervisors staff members. Fourteen of the 28 employees serve in a "subject matter expert" role for the particular BCC.

Recommendation

I recommend the Board of Supervisors provide direction regarding the conditions under which paid County employees are permitted to hold Board of Supervisors-appointed positions on Pima County Boards, Commissions and Committees.
