ITEM SUMMARY, JUSTIFICATION and/or SPECIAL CONSIDERATIONS:

RESOLUTION NO. 2013 - ____, A resolution of the Board of Supervisors permitting the intermittent, temporary closure of Silverbell Road in Pima County, Arizona, for the El Tour De Tucson on November 23, 2013. Staff recommends **APPROVAL**. (District 3)

The reason for this resolution is that the Perimeter Bicycling Association of America, Inc., requests permission to provide a convenient method of access to Silverbell Road for business owners and residents during the El Tour De Tucson on Saturday, November 23, 2013 from 6:00 A.M. to 5:20 P.M., which is recognized sunset for this date. The Pima County Sheriff's Department shall enforce A.R.S. § 28-817(A) after 5:20 P.M. on Silverbell Road in Pima County jurisdiction.

The Pima County Sheriff's Department, the Pima County Department of Transportation, the Town of Marana Police Department, the Town of Marana Department of Transportation, the City of Tucson Police Department and the City of Tucson Department of Transportation agree that Silverbell Road should remain open to mechanized traffic only in the northbound lane, be restricted to bicycle traffic only in the southbound lane, and be intermittently, temporarily closed during peak demand periods with a temporary posted speed limit of 25 miles per hour during the El Tour De Tucson 2013 event.

The limit of this resolution is Silverbell Road from the City of Tucson limit to the City of Tucson limit (0.083 miles south of Sweetwater Drive to 0.008 miles south of Sweetwater Drive), from the City of Tucson limit to the Town of Marana limit (0.082 miles north of Kiley Court to 0.168 miles north of Sunset Road), from the Town of Marana limit to the Town of Marana limit (0.220 miles north of Mallow Lane to 0.009 miles north of Abington Road), from the Town of Marana limit to the Town of Marana limit (0.040 miles north of Twin Peaks Road to 0.109 miles north of Twin Peaks Road), from the Town of Marana limit to the Town of Marana limit (0.139 miles north of Twin Peaks Road to 0.267 miles north of Twin Peaks Road), from the Town of Marana limit to the Town of Marana limit (0.367 miles north of Coachline Boulevard to 0.025 miles east of Jackson Flats Trail).



WHEREAS, the Perimeter Bicycling Association of America, Inc. requested the temporary closure of Silverbell Road from the City of Tucson limit to the City of Tucson limit (0.083 miles south of Sweetwater Drive to 0.008 miles South of Sweetwater Drive) to the Town of Marana limit (0.367 miles north of Coachline Boulevard to 0.025 miles east of Jackson Flats Trail) on Saturday, November 23, 2013 from 6:00 A.M. to 5:20 P.M. in Pima County jurisdiction to facilitate this event, and

WHEREAS, the Pima County Board of Supervisors has determined that it will be necessary to permit the temporary closure of Silverbell Road to support this event,
