ITEM SUMMARY, JUSTIFICATION and/or SPECIAL CONSIDERATIONS:

ORDINANCE NO. 2013 - ____, An ordinance of the Pima County Board of Supervisors, establishing prima facie reasonable speed limits for motor vehicles on Wade Road in Pima County, Arizona. Staff recommends **APPROVAL**. (District 3)

The reason for this ordinance is to reduce the speed limit along Wade Road to promote safety and consistency along the major collector routes consisting of Ina Road, Wade Road, and Picture Rocks Road.

A 2013 crash assessment and follow-up speed limit review has determined that the speed limit on the 0.6 mile long segment of Wade Road from Picture Rocks Road to Ina Road should be reduced from 45 miles per hour (mph) to 35 mph to provide continuity between adjacent roadway segments. The speed limits on the remaining segments of Wade Road have not changed.



**AN ORDINANCE OF THE PIMA COUNTY BOARD OF
SUPERVISORS ESTABLISHING PRIMA FACIE
REASONABLE SPEED LIMITS FOR MOTOR VEHICLES ON
WADE ROAD IN PIMA COUNTY, ARIZONA**

WHEREAS, the Board of Supervisors of Pima County, Arizona, has the authority under Title 28 of the Arizona Revised Statutes, more specifically Sections 28-627, 28-701 and 28-703, as amended, to fix prima facie reasonable speed limits on through highways, and

WHEREAS, the Board of Supervisors of Pima County, Arizona, has determined the prima facie reasonable speed limits for motor vehicles on portions of Wade Road,

THEREFORE, IT IS HEREBY ORDAINED by the Board of Supervisors of Pima County, Arizona, that:

SECTION 1. The reasonable and safe prima facie speed limit on Wade Road shall be established as follows:

| <u>SPEED LIMIT</u> | <u>FROM</u> | <u>TO</u> |
|--------------------|--------------------|---------------|
| a) 35 mph | Los Reales Road | Valencia Road |
| b) 35 mph | Picture Rocks Road | Ina Road |

SECTION 2. Ordinance 2013-19 is repealed and all other ordinances or parts of ordinances in conflict herewith are superseded to the extent of such conflicts.

SECTION 3. This ordinance shall take effect when and to the extent that signs are posted on the highways herein listed giving notice of the prima facie reasonable speed limits.

SECTION 4. Violators of this ordinance shall be subject to civil or criminal sanctions as provided by law.

SECTION 5. The various county officers and employees are authorized and directed to perform all acts necessary or desirable to give effect to this ordinance.


