Agenda Item #17: Facilities Management - Valencia Tech Park, L.L.C., to provide a lease agreement for space located within 3000 E. Valencia Road, Suite 190, for the Pima County Recorder's Office.

Recommendation: any changes made to the Recorder's office must include increased transparency to the public of all business conducted within the office, including the receipt and storing of ballots as well as the curation of the voter rolls. The Pima County voter Rolls need to be scrubbed. We put a man on the moon in 1969, using slide rules to design the equipment, but Pima County still can't check voter rolls in 2024.

Agenda Item #36: GRANT ACCEPTANCE – Health - Department of Health and Human Services, Centers for Disease Control and Prevention, Amendment No. 1, to provide for the Pima County Overdose Data to Action: LOCAL - <u>Pima CARES and amend grant</u> <u>language</u>, \$2,544,375.00 (<u>GA-HD-69959</u>).

Recommendation:

Please rethink your strategy on the overdose epidemic in Pima County. The BoS must be proactive instead of reactive and stop the drug flow *at the border BEFORE* the drugs get to our communities. The Pima County citizens are aware that half the funding for these grant programs is spent on administrative costs and provide minimal, if any, effective outcomes. The Pima County citizens are keeping a close eye on these program outcomes and expect complete transparency with regard to this program's effectiveness.

Agenda Item #37: GRANT ACCEPTANCE – Health - Arizona Department of Health Services, to provide for the American Rescue Plan, \$2,655,000.00 (G-HD-79202).

Recommendation:

Does anyone believe COVID-19 tests and vaccines are a priority for domestic violence survivors? NO! Interesting that the federal government grants for the "not so legal immigrants" did not force the COVID-19 vaccines but they never had a problem forcing it on the US citizens.
