ITEM SUMMARY, JUSTIFICATION and/or SPECIAL CONSIDERATIONS:

Resolution for the Abandonment of a County Highway within the incorporated limits of the City of Tucson, Pursuant to the IGA with the City of Tucson T13S-R14E Sections 20, 21 and 28, for the River Road/Alvernon Way Improvement Project from Campbell Avenue to Alvernon Way.

The purpose of the resolution is to abandon a County Highway that lies within the incorporated limits of the City of Tucson. Said roadway described in attached Exhibit "A".

The petition and County Highway designations were approved by the Board of Supervisors on November 9, 2004, under Proceeding No. 2981, permitting the expenditure of County Bond Funds made available for projects from County Bonds authorized in the November 4, 1997 Special Bond Election.

The project has been completed and the Pima County properties have been designated as Public Road Right-Of-Way as recorded under Sequence No. 20113490082. Therefore, it is now time to return the designated roadway to the City of Tucson.

WHEREAS, the Pima County Board of Supervisors established a portion of River Road within the incorporated limits of the City of Tucson as a County Highway Resolution and Order Number 2004 – 302 (under Establishment Proceeding Number 2981) and as depicted in attached Exhibit A, and

WHEREAS, the establishment of said roadway was accomplished for the purpose of performing bond funded roadway improvements made pursuant to an intergovernmental agreement between Pima County and the City of Tucson, and

WHEREAS, the City of Tucson has inspected, approved and accepted the completed improvements to the aforementioned roadway and agreed by way of the aforementioned intergovernmental agreement to accept said improvements into the City's roadway maintenance system, and

WHEREAS, the Board of Supervisors is authorized by A.R.S. § 28-6701(B) and A.R.S. § 28-7212(B) to abandon to an incorporated city or town that portion of a county highway lying within the incorporated limits of the city or town,

NOW, THEREFORE, IT IS HEREBY RESOLVED by the Board of Supervisors of Pima County

that:

1. The county highway established by Pima County Board of Supervisors Resolution and

Order Number 2004 - 302 (under Establishment Proceeding Number 2981) is hereby ordered

abandoned to the City of Tucson effective the date of this Order.

2. It is further ordered that the Clerk of the Board of Supervisors shall record this

Resolution and Order, together with a map of said highway abandoned, in the Office of the

County Recorder, Pima County, Arizona.

3. The various County officers and employees are authorized and directed to perform all

acts necessary or desirable to give effect to this Resolution.


