WHEREAS, Roy Schoonover has tirelessly dedicated his time as a volunteer in bicycling advocacy and has been recognized by several organizations for his efforts;

WHEREAS, the Board of Supervisors of Pima County finds that Roy Schoonover is exceptionally worthy of recognition and wishes to rename the Julian Wash Greenway Trailhead at Kolb Road in his honor;

NOW, THEREFORE, the Board of Supervisors of Pima County resolves that:


