***Project Title/Description:**

Youth CareerConnect (YCC) - Provide Science, Technology, Engineering, and Math (STEM) training. The original contract and amendments may be found under CT-15*020. Search contract number 15%020 in eContracts.

***Purpose:**

Santa Cruz County Regional School District will provide education and training pathways that offer rigorous academic and technical curriculum focused on specific careers in the applied information and health technology, industrial technology, biotechnology and aviation technology industries to youth in grades 9-12 in Santa Cruz County. This program and contract was initiated before the new Uniform Grant Guidance (UGG) went into effect so this amendment is to modify the terms of the contract to include the UGG requirements.

***Procurement Method:**

County applied for a Youth CareerConnect grant for the U.S. Department of Labor Employment and Training Administration and the County was awarded \$5,351,690.00. Santa Cruz County Regional School District was a partner in the application.

***Program Goals/Predicted Outcomes:**

Santa Cruz County Regional School District was awarded \$1,255,381.00 for four years to provide case management and support services for 417 youth.

***Public Benefit:**

Support economic development efforts by helping to develop a trained and productive labor force that meets regional employers' needs.

Pima County a body politic and corporate of the State of Arizona (“County”) and Santa Cruz County (“Santa Cruz”) have entered into the above referenced Intergovernmental Agreement (“Agreement”) to provide workforce development services for youth and adults in Southern Arizona. The original contract may be found as Number CT-CS-15-020 in eContracts.

AMENDMENT NO. 4

A. County, as Grantee, received federal Youth CareerConnect (“YCC”) grant funds to provide workforce development services for youth. The YCC grant ends September 30, 2018.

- B. Santa Cruz is a Subrecipient of YCC grant funds.
- C. The issuance of new Office of Management and Budget Circulars regulations requires a modification to the terms of this Agreement.

NOW, THEREFORE, County and Santa Cruz agree to amend the Agreement as follows:

1. **ARTICLE IX – COMPLIANCE WITH LAWS**, is amended as follows:

1.1. **Paragraph B** is deleted in its entirety and replaced with the following:

B. Santa Cruz warrants that YCC funds provided for personnel employed in the administration of the program funded under this Agreement will not be used for:

- 1. Political activities;
- 2. Inherently religious activities;
- 3. Lobbying;
- 4. Political patronage; or
- 5. Nepotism activities.

1.2. **Paragraph C** is added to read:

C. Santa Cruz will comply with the applicable provisions of:

- 1. Davis-Bacon Act (Pub. L.107-217), (40 U.S.C. §§ 276a to 276a-7) as supplemented by Department of Labor regulations (29 CFR Part 5) as amended;
- 2. Copeland Anti-Kick Back Act (18 USC 874 et seq.);
- 3. Arizona Address Confidentiality Program (A.R.S. § 41-161 et seq.);
- 4. Uniform Administrative Requirements (29 CFR Parts 95 and 97);
- 5. Fingerprinting, certification, and criminal background checks including, but not limited to the applicable provisions of: A.R.S. §§ 8-804, 36-594.01, 36-3008, 41-1964, and 46-141;
- 6. Clean Air and Clean Water Act (42 U.S.C.1857(h), section 508 of the Clean Water Act (33 U.S.C. 1368) Executive Order 11738, and Environmental Protection Agency regulations (40 CFR part 15);
- 7. Energy Policy and Conservation Act (Pub. L. 94-163, 89 Stat. 871);
- 8. Debt Collection and Audit Resolution (Pub. L. 105-220 Sections 128, 133, and 184; 20 CFR Part 652, Subpart D,E and G; 20 CFR Part 667 Subparts D – H; 29 CFR Parts 95, 96, 97, and 99; OMB Circular A-21; 2 CFR 200 and all subparts; Federal Acquisition Regulation 97-03 Part 31.);
- 9. Child Labor Laws (A.R.S. §23-230 et seq.);
- 10. Debarment and Suspension (29 CFR Part 98 and Executive Order 12549);
- 11. Environmental Tobacco Smoke (Pub. L. 103-227, Part C);
- 12. Nondiscrimination and Equal Opportunity Requirements pursuant to 29 CFR Parts 30, 31, 32, 33, 34, 36 and 37.
- 13. Workforce Innovation and Opportunity Act, Pub.L.113-128; and
- 14. All rules and regulations applicable to the Acts set forth above.

2. **EXHIBIT C – SUBCONTRACTOR'S WARRANTIES** is deleted in its entirety.






