**\*Title:**

Road Proceeding No. A-0070: IGA Abandonment of Broadway Blvd between Euclid Ave and Campbell Ave

**\*Introduction/Background:**

Resolution for the Abandonment of a County Highway within the incorporated limits of the City of Tucson, pursuant to the IGA with the City of Tucson within portions of Sections 7, 8, 17, and 18, T14S, R14E, for the Broadway Boulevard IGA Improvement Project. Roadway is described in attached Exhibit "A". The petition and County Highway designations were approved by the Board of Supervisors on January 11, 2005, under Proceeding No. 2984, permitting the expenditure of County Bond Funds made available from County Bonds authorized in the November 4, 1997 Special Bond Election. The project has been completed and the Pima County properties have been designated as Public Road Right-Of-Way as recorded under Sequence No. 20050120583. Therefore, it is now time to return the designated roadways to the City of Tucson.

**\*Discussion:**

If Approved: The Improved roadway for the Pima County Bond Project will be returned to the City of Tucson. Pima County would be in compliance with the IGA per Reso&Order No. 2004-343, recorded under Seq: 20050150535.

**\*Conclusion:**

If Denied: The IGA clause requiring the abandonment of a segment of roadway for Broadway Boulevard, between Euclid Avenue and Campbell Avenue, back to the City of Tucson upon completion of project would not be implemented. Pima County would be in violation of the IGA per Reso&Order No. 2004-343, recorded under Seq:20050150535.

**RESOLUTION AND ORDER NO. 2023 -**

**A RESOLUTION AND ORDER OF THE BOARD OF SUPERVISORS OF PIMA COUNTY, ARIZONA, ABANDONING A COUNTY HIGHWAY WITHIN THE INCORPORATED LIMITS OF THE CITY OF TUCSON FOR THE BROADWAY BOULEVARD IGA BOND IMPROVEMENT PROJECT BETWEEN EUCLID AVENUE AND CAMPBELL AVENUE, SITUATED WITHIN SECTIONS 7, 8, 17, AND 18, TOWNSHIP 14 SOUTH, RANGE 14 EAST, GILA AND SALT RIVER MERIDIAN, PIMA COUNTY, ARIZONA.**

**UNDER PROCEEDING NO. A-0070**

**The Board of Supervisors of Pima County, Arizona finds:**

1. The Pima County Board of Supervisors established a portion of Broadway Boulevard between Euclid Avenue and Campbell Avenue within the incorporated limits of the City of Tucson as a County Highway Resolution and Order Number 2005-15 (under Establishment Proceeding Number 2984) and as depicted in attached Exhibit A.
2. The establishment of said roadways was accomplished for the purpose of performing bond funded roadway improvements made pursuant to an intergovernmental agreement between Pima County and the City of Tucson, per Resolution and Order Number 2004-343 and recorded under Sequence Number 20050150535.
3. The City of Tucson has inspected, approved, and accepted the completed improvements to the aforementioned roadway and agreed by way of the aforementioned intergovernmental agreement to accept said improvements into the City's roadway maintenance system.
4. The Board of Supervisors is authorized by A.R.S. §28-6701(B) and A.R.S §28-7212(B) to abandon to an incorporated city or town that portion of a county highway lying within the incorporated limits of the city or town.

**NOW, THEREFORE, BE IT RESOLVED THAT:**

1. The county highway established by Pima County Board of Supervisors Resolution and Order Number 2005-15 (under Establishment Proceeding Number 2984) is ordered abandoned to the City of Tucson effective the dated of this Order.

2. The Clerk of the Board is hereby directed to record this Resolution and Order, together with a map of said highway, as Abandonment Proceedings No. A-0070 in the Office of the Pima County Recorder, Pima County, Arizona.
3. The appropriate County officers and employees are hereby authorized and directed to perform all acts necessary and desirable to give effect to this Resolution.

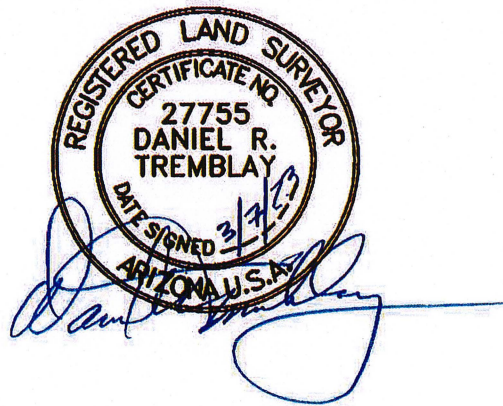

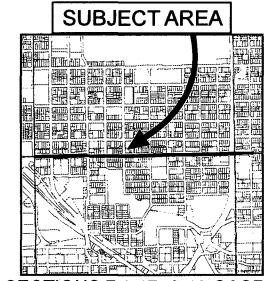
**EXHIBIT "A"**

**ABANDONMENT PROCEEDINGS NUMBER A-0070**  
**BROADWAY BOULEVARD – EUCLID AVENUE TO CAMPBELL AVENUE**

Broadway Boulevard, as shown as existing right-of-way on the City of Tucson City Engineer's Plan No. R-89-05, also known as the BROADWAY CORRIDOR STUDY, on file in Maps and Records in the Office of said City Engineer, from 500 feet westerly of the centerline of the intersection of Broadway Boulevard and Euclid Avenue, to 500 feet easterly of the centerline of the intersection of Broadway Boulevard and Campbell Avenue, lying within Sections 7, 8, 17, and 18, Township 14 South, Range 14 East, Gila and Salt River Meridian, Pima County, Arizona.

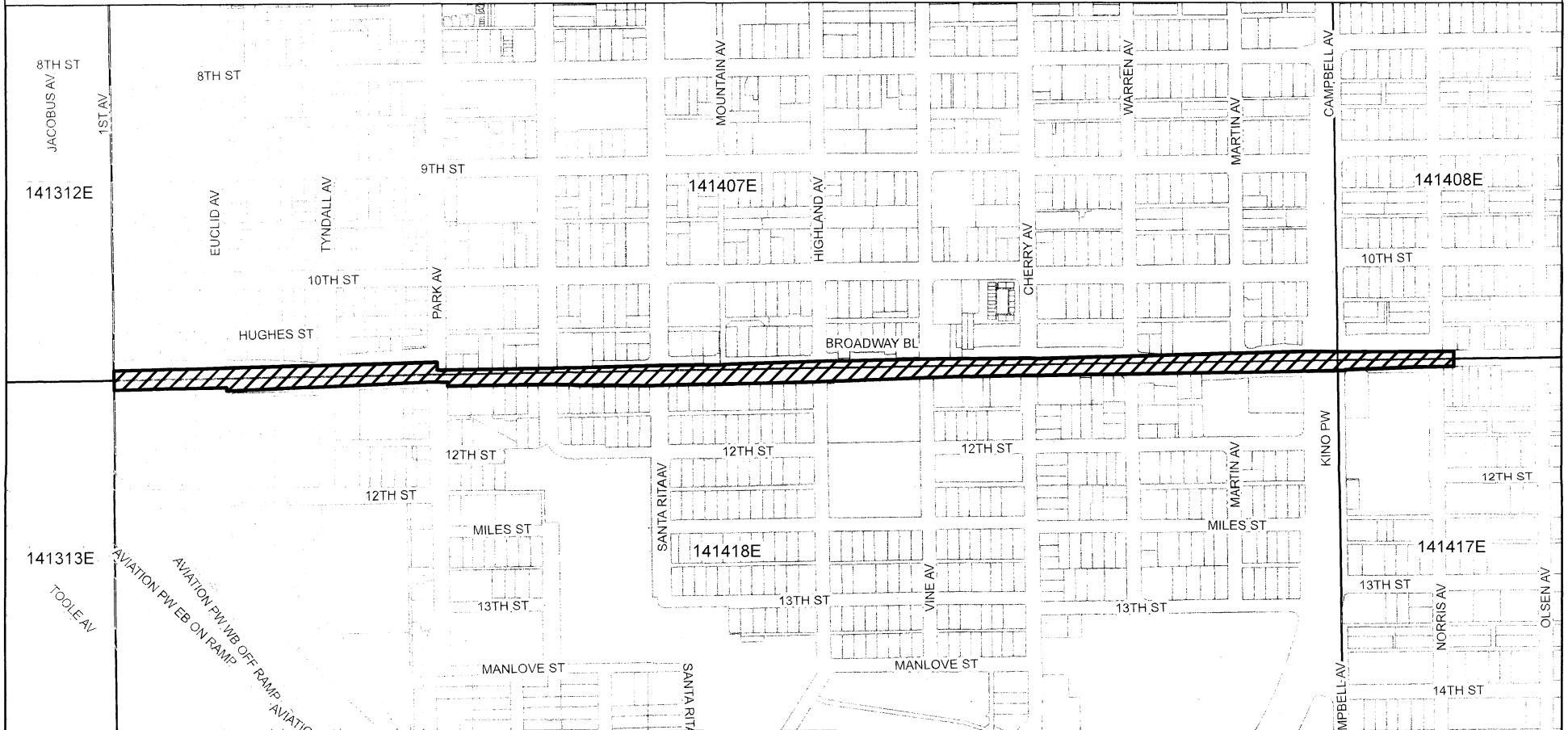


# DEPICTION OF EXHIBIT "A"
