RESOLUTION OF THE PIMA COUNTY BOARD OF SUPERVISORS
ELECTING PARTICIPATION BY PIMA COUNTY IN THE FAMILY COUNSELING
PROGRAMS

WHEREAS, A.R.S. sections 8-261 through 8-265 provide for the establishment and administration of voluntary Family Counseling Programs ("the Programs") to be administered by the juvenile division of the superior court;

WHEREAS, the purpose of the Programs is to provide counseling services to families in order to help strengthen family relationships and prevent juvenile delinquency;

WHEREAS, in fiscal year 2012-2013 the Programs provided services to 96 youth and/or families in Pima County;

WHEREAS, pursuant to A.R.S. section 8-264(A), Pima County may elect to participate in the Programs for fiscal year 2014-2015 by resolution of the Pima County Board of Supervisors;

WHEREAS, A.R.S. section 8-261(4) requires Pima County to provide a match to State appropriations for the Programs; and

WHEREAS, the Programs for fiscal year 2014-2015 require \$21,553.00 in matching funds from Pima County, which funds are budgeted and available in the budget for the Pima County Juvenile Court.

NOW THEREFORE, BE IT RESOLVED by the Board of Supervisors of Pima County, Arizona, that Pima County elects to participate in the Programs for fiscal year 2014-2015 and to provide \$21,553.00 in matching funds in accord with the fiscal year 2014-2015 budget.
