
In the year 2019 the manufacturer, Arrow International, sent a memo to all distributors stating that all parts for machines ten (10) years and older are hard to find, most impossible. Going forward, anything older than ten (10) years is no longer officially serviced.

When a bingo game purchases new bingo equipment it is common for them to sell off their old equipment to another game. With the scarcity of parts and we as distributors no longer servicing them, old equipment holds zero value for resale or otherwise. Note that some people do try and sell their old equipment through online means like Craigslist.com etc., this is done by the person that owns said equipment, not Cactus Bingo Supply. We do not condone this as no one can guarantee service but we are not the police and it is not against the law to resale old bingo equipment if a willing buyer is found. Unscrupulous maybe but not against the law.

Paradise R.V., in Sun City AZ, was told this when they asked what they should sell their old equipment for, since they just purchased brand new equipment. Knowing the BK700 and the BK Autotronic Flashboard does not hold any value for resale or otherwise they wanted to donate it to someone that was in need. I told her about The Green Valley Foundation, as Maribeth and I had just started talking, that they were looking to start a bingo fundraising program and needed equipment. She was very excited that it would go to a proper charity and said yes.

Paradise R.V. has clearly taken very good care of the equipment, it is rare to see a machine this age and in such clean condition. Cactus Bingo is going over the machine to ensure it is completely functioning, both the BK7000 console/desk and the BK Autotronic Flashboard. The only thing to be charged, which will be on a separate quote, will be a trip charge of \$175.00 for delivery and a \$75.00 hourly charge for having the tech present to install and train on equipment. It is not a complicated machine and does not take long to learn. It is anticipated that the tech will need to be there for two (2) hours maximum, if all goes smoothly. There are no flashboards being hung up on the walls nor are cables being run through a ceiling so most of the tech's time will be spent teaching and going over equipment usage and any other questions people may have.
