



An election for Member of the Board of Directors will be held on November 11, 2014 at the following place:



CALL TO ORDER AND ROLL CALL

Call to Order and Roll Call: Mr. Crockett called the meeting to order at 4:05pm. Upon Roll Call the following answered present: Mr. Valenzuela and Mr. Anderson.

Consideration for Approval of Meeting Notice and Agenda for the November 17, 2014 Special Meeting: Mr. Crockett stated the next item of business was 'Consideration for Approval of Meeting Notice and Agenda for the November 17, 2014 Special Meeting'; whereupon Mr. Anderson moved, seconded by Mr. Valenzuela and the motion carried, that: the Meeting Notice and Agenda of the November 17, 2014 Special Meeting of the Flowing Wells Irrigation District Board of Directors is approved and adopted as posted and circulated.

ELECTION BUSINESS

Ratify Appointment of an Election Board to oversee and manage the election for member of the Board of Directors held November 2014: Mr. Crockett stated the next item of business was 'Ratify Appointment of an Election Board to oversee and manage the election for member of the Board of Directors held November 2014.'

At the October 7, 2014 Board meeting, Aaron Marsteller and Mary Peduchi were appointed to serve as the Election Board for the election of a member of the Board of Directors of Flowing Wells Irrigation District to be held November 11, 2014. Subsequent to the appointment, Aaron Marsteller informed the District he would be unable to serve. Therefore, another qualified elector, Jesus Martinez, was asked to serve in Mr. Marsteller's absence.

Whereupon, Mr. Anderson moved, seconded by Mr. Valenzuela and the motion carried, that: ratification of the substitute member, Jesus Martinez, of the Election Board be approved.

Consideration for Approval: Canvass of the results of the Election for Member of the Board of Directors held November 2014: Mr. Crockett stated the next item of business was 'Consideration for Approval: Canvass of the results of the Election for Member of the Board of Directors held November 2014.' Mr. Crockett then advised the Board that it was the date and hour set for the Canvass for the returns of the Member of the Board of Directors Election held in the District on November 2014, that being the first Monday following the day of the Election as prescribed by statute.

The Election Board having caused the returns of the Election to be delivered to the District's Board of Directors within the time prescribed by law (ARS §48-3020), the Board examined and found the election material properly secured with all seals in place. Upon opening the Official Returns Envelope and the Ballot Envelope and examining the returns of the Election, the Board of Directors found that thirteen (-13-) mail-in votes and zero (-0-) other vote(s) had been cast; that thirteen (-13-) ballots were cast for Mack Dickerson; that there were zero (-0-) unmarked ballot(s); zero (-0-) invalid write-in ballot(s); that there were zero (-0-) ballot(s) spoiled or rejected; that no challenges had been filed as to the qualification of any elector; that the Election had been conducted and the returns thereof made as required by law and; that only qualified electors were permitted to vote at the Election.

Therefore, it was moved by Mr. Anderson, seconded by Mr. Valenzuela and passed, that the following order be entered upon the Minutes of the Meeting:

BE IT HEREBY ORDERED AND DETERMINED BY THE BOARD OF DIRECTORS OF FLOWING WELLS IRRIGATION DISTRICT OF PIMA COUNTY, ARIZONA:

THAT a majority of the votes cast by qualified electors of the District voting at the Election for Member of the Board of Directors were for Mack Dickerson; that his term of office shall begin January 1, 2015 and end December 31, 2017, and that the Secretary of this Board is hereby authorized and directed to enter into the proceedings of the Board of Directors a statement of such declared result. Further, that; in accordance with ARS §48-3022, the Secretary of the Board of Directors is directed to enter upon the record a statement of the Election results as follows: a copy of the Notice of Election, which is attached hereto as Exhibit A, further that; the names of the Judges for the Election Board were Mary Peduchi and Jesus Martinez, further, that; the total number of votes cast in the District were thirteen (-13-), further, that; the name of the person receiving a majority of the votes was Mack Dickerson, further, that; the office for which the Election was held was Member of the Board of Directors, further, that; the number of votes cast in the District for the candidate was thirteen (-13-), further, that; Mack Dickerson was declared elected, and further; the District's superintendent is directed to transmit a copy of same to the Clerk of the Pima County Board of Supervisors.




