Background

On February 4, 2015, the County Administrator pursuant to Pima County Procurement Code 11.12.060; Emergency and other limited competition procurement, approved a limited competition process and a solicitation was conducted for E-Rate Category One Wide Area Network and Internet Services. Notice of solicitation 170928; E-Rate Priority One Wide Area Network and Internet Services, was transmitted to seven (7) potential respondents, which were the vendors approved under State Master Blanket Purchase Order #ADSPO15-088468 (solicitation #ADSP014-00004241) to provide carrier and broadband services within Pima County.

Pursuant to the solicitation terms, the award is recommended to the firm determined to be the most advantageous to County, taking into consideration the Cost/Value of services and Level/Adequacy of the services, as evaluated by the Information Technology evaluation team.

I request your approval of the limited competition procurement described below. This limited competitive process is requested to allow the County to utilize the new State Carrier and Broadband Provider Services Master Contract to procure services while abiding by Federal Procurement guidelines for the E-Rate program, making compliance with normal purchasing procedure timelines impracticable.

The Pima County Libraries need to have their Wide Area Network (WAN) connections upgraded to be able to provide the services the library patrons of Pima County expect and deserve. Based on two new Executive Orders pertaining to the Schools and Libraries Division (E-Rate) of the Universal Service Administrative Company (administrative organization chosen by the FCC to manage its Universal Service Fund) the State of Arizona Carrier and Broadband Provider Services Master Contract was delayed to ensure it met the new guidelines that were imposed by the orders. Because of the delay in the issuance of the State Master Contract, there is now a narrow window in which the County can apply to receive funding for these connections. Recent efforts by the County have ensured we are receiving a discount rate of at least 75% on our bills for the services we are seeking to be funded by the Universal Services Fund (USF) if we are able to meet the E-Rate timelines. On February 7, 2015, the library staff members will file the Form 470 which will allow the County to seek proposals for services to be funded with USF monies. The E-Rate process requires applicants to wait a minimum of 28 days from the posting of the Form 470 to select the winning vendor and award a contract, thus the soonest a contract can be awarded for these services is March 06, 2015. Once the contract has been awarded a Form 471 must be filed to indicate to the Schools and Libraries Division of the Federal Communications Commission that the County has selected the vendor it will work with for the indicated services. The last day that a Form 471 can be filed for this years' E-Rate funding cycle is March 26, 2015.

On September 4, 2014, the Arizona State Procurement Office submitted their own Form 470 and went through a thorough RFP process for Telecommunications Carrier and Broadband services so schools and libraries within the State could apply for E-Rate funding while purchasing their telecommunications services off of this State contract (and not have to run the full bid process themselves). The State will award the Telecommunications Carrier and Broadband contract to multiple vendors, only some of which can provide services within Pima County on February 6, 2015.

Based on the procurement rules for E-Rate funding, it is our intent to utilize this multi-award state contract to purchase the needed services for the Pima County Library District. To do so we will request proposals from vendors on the State of Arizona Carrier and Broadband Provider Services Master Contract that are able to provide services within Pima County and then we will score the proposals against a predetermined scoring matrix, approved by Procurement. We will award the contract to the vendor with the highest ranking proposal. We plan to have the completed contract available for execution by the Chairman of the Board of Supervisors by March 17, 2015. .

This limited competition procurement allows the County to procure the much needed services while meeting the very tight timelines that are in place for the E-Rate application cycle, and is in the best interests of Pima County. The Procurement Department will achieve the maximum practicable competition in the circumstances.

- 2) Able to get to 96% of Library sites = 85 points X 96% = 81.6 = 82 points (26 sites available and COX can get to 25 of them-25/26=.9615%)
- 3) No ineligible goods and services proposed = 75 points
- 4) Provide a minimum of 99.9% uptime within 2 hours = 60 points
- 5) Able to provide QoS and at the lowest price point = 50 points (COX provides QoS at no additional cost, so received the additional 25 points)

CenturyLink:

Based on statistics from this year and previous years of Internet utilization for the Library District we forecasted that we will not have the need to increase our Internet bandwidth to speeds greater than 1000Mbps for several years. Since the initial award for this contract is 5 years we chose to evaluate the throughput speeds that might (but highly unlikely) be considered within that 5 year time period. Based on the pricing below, not only is COX the lowest price for the 1000Mbps requested in the solicitation, but they also are the lowest overall price up to 4000Mbps (which we don't envision surpassing in the first 5 years of the contract). In column B we show the price per month from the providers proposals. In column C we assumed that the throughput would be 1000Mbps for the first 2 years of service. We then went on to show the bandwidth speed increasing by 1000Mbps each year for the following 3 years (again highly unlikely) and have shown the total costs to the County if that were to happen.
