## ITEM SUMMARY, JUSTIFICATION &/or SPECIAL CONSIDERATIONS:

The Arizona Early Childhood Development and Health Board (First Things First) has contracted the Pima County Health Department to provide initial and ongoing training for the Arizona Child Care Health Consultation System (CCHCs), Health Champion training for child care providers, development and maintenance of program policy and procedures, and technical assistance for providers.

Amendment 1 adds one year to the term of the grant and funds the additional year's activities by adding \$100,000.
