Title: Camino Verde and Brightwater Way/Valley Stream Drive All-Way Stop

Introduction/Background:

The reason for this ordinance is to establish Camino Verde and Brightwater Way/Valley Stream Drive as an all-way stop controlled intersection. This intersection is located in the Star Valley subdivision.

Discussion:

Camino Verde at Brightwater Way/Valley Stream Drive became a four-legged all-way stop controlled intersection as part of the Camino Verde extension project from Valencia Road south to Brightwater Way/Valley Stream Drive. Prior to this extension project the intersection was a three-legged all-way stop controlled intersection.

Conclusion:

Pima County Traffic Engineering recommends the intersection remain designated as an all-way stop controlled intersection in concurrence with the Camino Verde extension project.

Recommendation:

Pima County Traffic Engineering recommends approval of the all-way stop ordinance for Camino Verde and Brightwater Way/Valley Stream Drive to be in concurrence with A.R.S. 28-627 and 28-855.

ORDINANCE NO. 2016-__

AN ORDINANCE OF THE PIMA COUNTY BOARD OF SUPERVISORS REGULATING TRAFFIC AT THE INTERSECTION OF CAMINO VERDE AND BRIGHTWATER WAY/VALLEY STREAM DRIVE IN PIMA COUNTY, ARIZONA

WHEREAS, the Board of Supervisors of Pima County, Arizona, has the authority under Title 28 of the Arizona Revised Statutes, more specifically Sections 28-627 and 28-855, as amended, to designate stop intersections and to erect stop signs, and

WHEREAS, the Board of Supervisors of Pima County, Arizona, has determined that it is necessary for the protection and convenience of the traveling public of Pima County, Arizona, to designate the intersection of Camino Verde and Brightwater Way/Valley Stream Drive as an all-way stop intersection.

THEREFORE, IT IS HEREBY ORDAINED by the Board of Supervisors of Pima County, Arizona, that:

SECTION 1. The intersection of Camino Verde and Brightwater Way/Valley Stream Drive be designated as an all-way stop intersection.

SECTION 2. All other ordinances or parts of ordinances in conflict herewith are superseded to the extent of such conflicts.

SECTION 3. This ordinance shall take effect when and to the extent that stop signs are posted on the intersecting roadways.

SECTION 4. Violators of this ordinance shall be subject to civil or criminal sanctions as provided by law.

SECTION 5. The various county officers and employees are authorized and directed to perform all acts necessary or desirable to give effect to this ordinance.




