## FIFTH AMENDMENT TO LEASE 3950 SOUTH COUNTRY CLUB ROAD, SUITE #200 TUCSON, ARIZONA

- **DEFINED TERMS.** For purposes of this Amendment, the following terms have the 1. meanings set forth below:
- Landlord: Pima County, a political subdivision of the State of Arizona (hereinafter referred to as "Landlord")
- Tenant: ARIZONA BOARD OF REGENTS for and on behalf of the University 1.2. of Arizona.
- Leased Premises: Suite #200 in the building located at 3950 S. Country Club 1.3 Road, Tucson, Arizona, and known as the Abrams Public Health Building, consisting of approximately 13,492 rentable square feet.
- Lease: The lease for the Leased Premises naming Tenant as tenant, which 1.4 commenced on September 18, 2008, and all amendments thereto.
- MODIFICATION OF LEASE. Landlord and Tenant hereby agree to modify the terms 2. of the Lease as follows:
- Extension Of Lease: Landlord and Tenant hereby agree to extend the term of the 2.1. Lease for five (5) additional years from September 19, 2013 to September 18, 2018.

3. **REMAINING LEASE TERMS UNCHANGED.** Except as modified as provided in this Amendment, all of the terms and conditions of the Lease shall remain in full force and effect.
