Discussion/Action on the Pima County Attorney's Office request to utilize Anti-Racketeering Revolving Funds in support of 88-CRIME Inc.

#### \*Introduction/Background:

Funds are requested in the amount of \$2,500.00 for 88-CRIME rewards.

#### \*Discussion:

This request is for 88-CRIME agency. 88-CRIME Program was incorporated in 1980 to assist law enforcement agencies in obtaining information from the public about felonies and other serious crimes. The corporation developed community responses against crime by providing incentives such as rewards to members of the public who assist law enforcement agencies by providing information. Serving as a conduit between the community and Law Enforcement, 88-CRIME, Inc. operates an anonymous tip line for citizens to report information to help solve crimes. The tip line is operated by the Pima County Attorney's Office. 88-CRIME, Inc. is a nonprofit organization dedicated to supporting the 88-CRIME program by providing rewards to anonymous tipsters who provide useful information to law enforcement that leads to the apprehension and arrest of those suspected of committing crimes and by making the public aware of the anonymous tip through public-private partnerships, media collaboration, and various marketing efforts.

To qualify, a program must specifically involve law enforcement personnel or otherwise include specific content which extends or enhances the efforts of law enforcement in the community, such as assisting victims of crime, preventing crime including by providing programs for at-risk youth, deterring crime, rehabilitation of offenders, emergency response by law enforcement, protecting people and property from crime, reducing the effects of crime, etc.

#### Supporting Local Law Enforcement:

Our program is specifically designed to complement and enhance the work of local law enforecement, the dedicated men and women who protect and serve our community. By providing anonymous tips

What elements of the program specifically enhance or extend the efforts of law enforcement in the community, and how does the program do this?

Between July 1980 and December 2022, 88-CRIME tips have led to more than 6,305 felony arrests, resulted in more than 6,820 investigations being cleared, \$92.5 million dollars in illicit narcotic seizures and more than \$22.5 million dollars of recovered property and cash seizures. Tips have included information about homicides, robberies, sexual assaults, physical assaults, narcotic and firearms offenses, and fugitives from justice just to mention a few.
