*Discussion:

Amendment Request to Ordinance No. 2024-9: Fee Schedule for the Pima County Office of the Medical Examiner (PCOME)

Ordinance No. 2024-9, which outlines the current fee schedule for the Pima County Office of the Medical Examiner (PCOME), was adopted on July 16, 2024. We are requesting an amendment to this ordinance to establish a new fee structure for the cremation of Anatomical Biomedical Waste. This change will allow PCOME to utilize its existing crematory retorts as a new revenue stream, helping offset costs related to the PCOME Crematory, while also providing a local disposal service for organizations needing to dispose of Anatomical Biomedical Waste.

Additionally, we are requesting the removal of the fee structure for the reproduction of Kodachrome Slides, as PCOME no longer has the capability to create or reproduce these slides.

*Conclusion:

Ordinance No. 2024-9 needs to be amended to add a fee structure for cremating Anatomical Biomedical Waste and to remove the fee structure for Kodachrome Slides as the office no longer was the ability to create or create these items.

ORDINANCE 2025 –

AN ORDINANCE OF THE BOARD OF SUPERVISORS OF PIMA COUNTY, ARIZONA, RELATING TO THE PIMA COUNTY OFFICE OF THE MEDICAL EXAMINER; AMENDING FEES FOR SERVICES

THE BOARD OF SUPERVISORS OF PIMA COUNTY, ARIZONA FINDS THAT:

- 1. The Pima County Office of the Medical Examiner has authority under A.R.S. §§ 11-594(E), 11-597.02(D), and 39-121.01(D) to charge fees for services and materials.
- 2. The Board of Supervisors has determined that it is reasonable to amend the fees charged by the Office of the Medical Examiner in order to defray its reasonable costs.

BE IT ORDAINED BY THE BOARD OF SUPERVISORS OF PIMA COUNTY, ARIZONA:

SECTION 1. Section 1 of Ordinance 2024-9, adopted on July 16, 2024 is amended to read as follows:

Section 1. Unless otherwise agreed and memorialized in an Intergovernmental Agreement, the following fee schedule is adopted for the Pima County Office of the Medical Examiner:

I. SERVICE FEES

- A. Procedures for counties other than Pima:
 - 1) Autopsies \$3,000 per autopsy
 - 2) External Examinations \$1,000 per examination
 - 3) External Examinations with toxicology \$1,500 per examination
- B. Cremation authorization \$35.00 per authorization
- C. Body Storage Fees:
 - \$150 per day, 72 hours after notification body may be released for storage of non-jurisdictional deaths at the behest of a funeral home or other death care industry (hospital, tissue organization, etc.) establishment
 - \$150 per day for out-of-county indigent cases, 15 business days after notification body may be released
- D. Pathologists or Anthropologists fees \$600 per hour including travel, expert consultation time (including but not limited to review of records, telephone conferences, literature reviews, report preparation and other consultation

related preparation), court, depositions, interviews and waiting time as applicable

E. Incineration

- 1) Anatomical Biomedical Waste \$100.00 per box (40x20x20 or smaller)
 - a. \$50 additional fee if over 250 pounds
- II. Funeral directors or the funeral establishment they are associated with will supply body bags to replace those in which they receive decedents. Body bags are to be of the same type and quality as received. In lieu of this body bag exchange, the funeral director or funeral establishment may pay \$50 per bag.

III. REPRODUCTION COSTS

- A. Commercial: Fees assessed for reproduction of documents or materials for a commercial request may vary depending on the nature of the request and will be determined by the following:
 - 1) The cost of obtaining the materials;
 - 2) The cost of time, materials, equipment and personnel in producing the reproduction; and
 - 3) The value of the reproduction on the commercial market as best determined by the Pima County Office of the Medical Examiner

B. Non-commercial:

- 1) Tissue slides \$25 per slide
- 2) Photographs or other digital media (radiographs, etc.)
 - a. \$1 per print
 - b. Reproduction of digital media on a CD \$5
- 3) Copies of documents \$2 per complete document plus postage as necessary
- 4) Request for all items in chart flat fee of \$25
- C. Family members, health care providers and institutions, law enforcement and other appropriate government agencies will not be charged for reasonable reproduction of documents or photographs as determined by the Pima County Office of the Medical Examiner

IV. REQUESTS FOR EXTENDED RETENTION

- A. Tissue \$25 per month
- B. Toxicology/Histology
 - 1) Specimens retained at reference laboratory beyond standard retention fee as specified by reference laboratory
 - 2) Specimens retained at Pima County Office of the Medical Examiner beyond standard retention \$25 per month
 - 3) Fee to return specimen or tissue from lab for extended retention \$50

VI. INDIGENT INTERMENT PROGRAM

 - 1) Cost paid to third party for interment (when applicable) or \$750
 - 2) Viewing \$50
 - 3) Shipping of cremains \$200
 - 4) Death Certificates \$50 each

SECTION 2. This Ordinance is effective 30 days after adoption by the Pima County Board of Supervisors.

SECTION 3. If any part of this Ordinance is found to be unenforceable for any reason, all other parts nevertheless remain enforceable.

 - a. \$50 additional fee if over 250 pounds

Body bags are to be of the same type and quality as received. In lieu of this body bag exchange, the funeral director or funeral establishment may pay \$50 per bag.
