RESOLUTION 2015-\_\_\_\_\_

A RESOLUTION OF THE BOARD OF SUPERVISORS OF PIMA COUNTY, ARIZONA; RELATING TO PLANNING; AMENDING THE PIMA COUNTY COMPREHENSIVE PLAN LAND USE MAP FOR APPROXIMATELY 53.0 ACRES OF A 122-ACRE TOTAL PROJECT AREA, LOCATED ON THE NORTH SIDE OF E. TANQUE VERDE ROAD, APPROXIMATELY 2,300 FEET EAST OF N. HOUGHTON ROAD AND 1,150 FEET WEST OF N. TANQUE VERDE LOOP ROAD, IN SECTION 36 OF TOWNSHIP 13 SOUTH, RANGE 15 EAST, IN THE CATALINA FOOTHILLS SUBREGION.

IT IS RESOLVED BY THE BOARD OF SUPERVISORS OF PIMA COUNTY, ARIZONA AS FOLLOWS:

Section 1. The Pima County Comprehensive Plan Land Use Map, Catalina Foothills Subregion, is hereby amended to change the planned land use intensity category for approximately 53.0 acres of a 122-acre total project area, as referenced in Co7-13-07 Title Security of Arizona TR 2055 – E. Tanque Verde Road Plan Amendment, located on the north side of E. Tanque Verde Road, approximately 2,300 feet east of N. Houghton Road and 1,150 feet west of N. Tanque Verde Loop Road, in Section 36, Township 13 South, Range 15 East, as shown on the map attached to this Resolution as Exhibit A and incorporated by this reference, from Resource Transition (RT) to Low Intensity Urban 1.2 (LIU-1.2).

Section 2. The Pima County Comprehensive Plan Regional, Rezoning and Special Area Policies are hereby amended to include the subject site with the following Rezoning Policies:

- A. The footprint of the proposed development shall be roughly the same as the approved tentative plat on file with Pima County (P-1212-039, SR zoning, Desert Willow Ranch Lots 1-36).
- B. The post-development floodplain shall remain planned Resource Transition (RT).
- C. Conservation Lands System (CLS) compliance shall be addressed before the rezoning.

Section 3. The various County officers and employees are authorized and directed to perform all acts necessary to give effect to this Resolution.

Section 4. This Resolution shall become effective on the date of adoption.


