#### \*Introduction/Background:

Resolution for the sale of land conveyed to the State of Arizona under a Treasure's Deed, to Judy Motes

#### \*Discussion:

On January 31, 2023, tax parcel 301-67-1060 (the "Property") was conveyed by Treasurer's Deed, in Sequence 20230310203, to the State of Arizona due to Outstanding delinquent taxes. The Property is an approximately 1.196 acre site of vacant land located in the Diamond Bell Ranch Tucson Unit 9 subdivision, lot 106. The sale of the Property is pursuant to ARS 42-18303, to the highest bidder, which is Judy Motes

#### \*Conclusion:

The Pima County Treasurer's office will receive revenue for Property conveyed to the state for delinquent taxes, and the property will be restored to the tax roll.

#### \*Recommendation:

It is recommended that the Board of Supervisors approve the Resolution authorizing the sale of the Property to Judy Motes
