A RESOLUTION AND ORDER OF THE BOARD OF SUPERVISORS OF PIMA COUNTY, ARIZONA, PROVIDING FOR THE ESTABLISHMENT OF IRVING AVENUE AND TENNESSE PLACE, A COUNTY HIGHWAY SITUATED WITHIN SECTION 34, TOWNSHIP 14 SOUTH, RANGE 14 EAST, GILA AND SALT RIVER MERIDIAN, PIMA COUNTY, ARIZONA.

UNDER PROCEEDING NO. 3020

WHEREAS, the County Engineer has requested that the Pima County Board of Supervisors establish a county highway to be known as Irving Avenue and Tennessee Place located within a portion of Section 34, Township 14 South, Range 14 East, Pima County, Arizona, pursuant to Arizona Revised Statutes (A.R.S.) Section 28-6701(B), said roads being more fully described in attached Exhibit A, and

WHEREAS, the County Engineer filed a report and map of the proposed highway with the Board in accordance with A.R.S. § 28-6702(A)(1), and

WHEREAS, said petition for establishment was set for a hearing before the Board on March 17, 2015, in accordance with A.R.S. § 28-6703, and

WHEREAS, notice of the hearing was published once a week for two consecutive weeks in a newspaper of general circulation prior to the hearing, and

WHEREAS, at the hearing on the 17th day of March, 2015, the Board considered the feasibility, advantages and necessity of the highway sought to be established and determined the proposed highway to be a public necessity.

NOW, THEREFORE, IT IS HEREBY RESOLVED THAT:

- The public roadways described in the attached Exhibit A and commonly referred to as
 Irving Avenue and Tennessee Place are hereby established as a county highway.
- 2. The Clerk of the Board is hereby directed to record this Resolution and Order, together with a map of said highway, as Establishment Proceeding No.3020 in the Office of the Pima County Recorder, Pima County, Arizona.
- 3. The appropriate County officers and employees are hereby authorized and directed to perform all acts necessary and desirable to give effect to this Resolution.


