Justification for Teen Pregnancy Prevention Program, Amendment #2

The Pima County Health Department (PCHD) has provided the Teen Pregnancy Prevention Program for the last six years. This program is administered by the Arizona Department of Health Services, Bureau of Women's and Children's Health and is funded by voter approved Arizona State Lottery funds and federal Title V funds. Amendment #2 to ADHS13-034040 adds the program logic model and makes a couple of administrative changes. The annual amount of \$125,000 is unchanged.

PCHD subcontracts with Pima Prevention Partnership's Sin Puertas Program for the execution of this contract. Through this program, at-risk youth who have been referred to the agency by juvenile justice authorities and other sources receive comprehensive life skills education, including pregnancy prevention. Under the current contract, 250 youth are reached in a variety of community settings. Pima County Public Health Nurses provide workshops on health topics chosen by students and staff, to augment this educational program.

In 2013, 234 youth received HIV sex risk-reduction education using the evidence-based and culturally-responsive *¡Cuidate!* curriculum, which is designed specifically for Latino youth. Concurrent education regarding substance use and other co-occurring disorders are part of the total curriculum these youth receive. The long goal is to decrease teen pregnancies, births and STIs.

Program evaluation by ADHS has shown that positive results were seen after participation in the program. There were improved results in the post-tests' following markers, among others: The teens increased the likelihood of abstaining from sex in the next year (3.9% change from pre-test); participants demonstrated a 6.1% increase in understanding the prevention of STIs and pregnancy through abstinence; there was improvement in the understanding of the connection between substance (drugs/alcohol) use and the likelihood for sexual activity; the teens showed positive growth in their understanding about healthy relationships. The Pima County Teen Pregnancy Program showed results slightly higher than the composite for the State of Arizona.

Without this program, this population of 250 high risk adolescents in our community would not be exposed to the critical knowledge that impacts their ability to make positive decisions in their life. These are youth that are involved with the justice system, often substance using, at risk for co-occurring mental health disorders, and attending alternative high schools that may not be resourced to address their specific needs. This program has a far-reaching impact on the lives of the young people we serve, and supports positive decision making that will lead to a decreased pregnancy risk and avoidance of the attendant individual and societal consequences associated with teenage parenthood.

Logic Model Framework

GOAL: Describe the goal of your program: a broad statement of intended change which identifies the target population.

To prevent pregnancies/subsequent pregnancies and the incidence of Sexually Transmitted Infections among a population of 13-17 year old juvenile justice-involved youth in Pima County.

THEORY: Explain the theory behind why the program(s) approach will work.

By diverting youths to community-based treatment programs, rather than incarcerating them, juvenile justice agencies give justice-involved youths the opportunity to engage in much needed life skills education through their participation in treatment services and school. The Substance Abuse and Mental Health Services Administration (SAMHSA) found that diverting appropriate individuals from jail to community-based treatment shows benefits to the criminal justice system, the community and the diverted individual. The Teen Pregnancy Prevention program will use the evidence-based and culturally responsive *Cuidate* curriculum. *Cuidate* was evaluated in 2003 and found to be effective in reducing sexual activity, the number of sex partners, unprotected sex and increase condom use among Latino youths. This curriculum works with varied successful methods such as demonstrations, group discussion, lectures, video/music/games, practice and role play to achieve its objectives.

TARGET POPULATION: Describe the population of clients that will be served.

The Teen Pregnancy Prevention program will work with youth ages 13-17 that have been referred to Sin Puertas for services by the Pima County Juvenile Court Center or that are participating in educational services at charter schools and alternative programs that target at-risk youths including Pima Partnership Academy High School, Alta Vista High School, and Las Artes Arts and Education Center. The target group is a largely minority, Hispanic population, considered at-risk for unsafe sexual practices, based on community markers including high levels of poverty, below average student achievement, and a high number of single parent households. They are predominantly from geographic populations with high levels of crime, substance use and abuse, and high rates of high school dropouts.

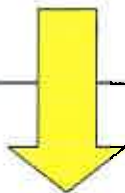

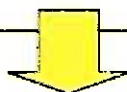

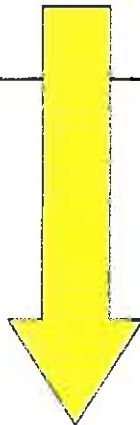

SHORT-TERM OUTCOMES: List the short-term benefits expected from the target population.

- Participating youth will increase their knowledge about HIV and sexually transmitted diseases.
- Participating youth will increase their knowledge about effective ways to prevent sexually transmitted diseases including HIV.

- Participating youth will have improved skills in negotiating abstinence and condom use.
- Participating youth will have improved attitudes and beliefs about condom use and negotiation skills.

- Participants will increase their knowledge about HIV and sexually transmitted diseases by 25%.

- 25% of participants will demonstrate improved attitudes and beliefs about condom use and negotiation skills.

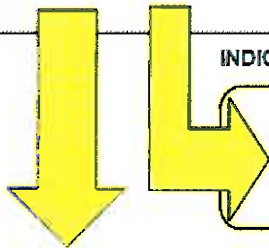
