Dear Pima County Supervisors:

I am writing to you as a concerned parent to thank you for adding Resolution of the Pima County Board of Supervisors Mandating the Use of Face Coverings in All K-12 Schools Within the County, as an Effective Mitigation Strategy to Keep our Children Safe from COVID-19; Effective Immediately to the Pima County Addendum Agenda for 8/16/21.

**I urge Pima County Supervisors to vote in favor of the County Resolution requiring a universal mask requirement in K-12 schools.**

Arizona is currently experiencing another COVID-19 surge, with cases having tripled over the past month, coinciding with the arrival of the highly contagious SARS-CoV-2 delta variant in the state. States all over the country are seeing an increase in cases among the unvaccinated, and this includes a drastic increase in child hospitalizations, many of whom are not yet eligible for vaccination. The Academy of Pediatrics recently reported that cases among US children and teens jumped 84% in a week.

According to Banner Health Chief Clinical Officer, Dr. Marjorie Bessel hospitals have seen a 95% increase in Covid-19 patients since July 1 and 300% increase in ventilators and there is substantial spread in the vast majority of Arizona counties. Arizona is also second in the nation for pediatric deaths related to COVID-19, according to data published recently by the American Academy of Pediatrics. Schools began welcoming back students to campus late last month and are already experiencing outbreaks across the state. Many are being forced back to online learning because they are not able to use simple mitigation tools like universal masking. The science around masking is settled. Masks work to prevent disease transmission. All recent public health agencies, both national and local, have issued statements recommending universal masks for K-12 students in schools.<sup>[1]</sup>

Arizonans have a right to safe schools for Arizona kids. Governor Ducey is attempting to prevent school officials from implementing any public health mitigation strategies in line with leading public health agencies, including the CDC and Arizona Department of Health Services (ADHS) to help protect students, all while COVID19 cases are again rising in our communities and more contagious variants are becoming more widespread.

The law passed by the state, banning schools from implementing such policies is likely unconstitutional,<sup>[2]</sup> doesn't take effect until Sept. 29 and poses a serious risk to life and health.

Governor Ducey is attempting to prevent school officials from implementing any public health mitigation strategies in line with leading public health agencies, including the CDC and Arizona Department of Health Services (ADHS) to help protect students, all while COVID19 cases are again rising in our communities and more contagious variants are becoming more widespread.

The law was passed by the state, banning schools from implementing such policies is likely unconstitutional, doesn't take effect until Sept. 29, and poses a serious risk to life and health. A complaint was just filed challenging the law with expedited consideration requested.

Pima County has a duty to protect the health of the community under Arizona law. Arizona Revised Statute Title 36 authorizes counties and local health jurisdictions to protect the health of the community during contagious diseases outbreaks. It is your duty to take action.

Dear supervisors,

I would like to begin with things I believe we can all agree on.

Things we like:

1. Children learning in school
2. Children having food security and a safe place to go everyday
3. Children participating in extracurricular activities
4. Children, teachers and staff feeling safe and supported by their community, school administrators and teachers, and employers
5. Business open and people employed resulting in a thriving local economy

Things we do not like:

1. Wearing a mask
2. Forcing children to wear masks and teachers to teach while wearing masks
3. Children and teachers being required to quarantine due to a COVID-19 exposure
4. Education being disrupted or going virtual for any amount of time due to a COVID-19 outbreak in a classroom
5. Cancellation of kids sports and other extracurricular activities due to a COVID-19 outbreak or significant community spread
6. Children having to worry about or mourn the loss of a teacher, classmate or loved one due to COVID-19
7. Parents or caregivers being forced to choose between employment or staying home with children who cannot be in school due to a COVID-19 outbreak

The BOS is being asked to make a decision that directly affects our ability as a community to get what we like and want and avoid the things we don't. The options are;

1. No mask mandate for K-12.

We get to avoid items 1 & 2 that we don't like. Great. This option allows us to get all the things we like, for now. However, the risk of eventually having to deal with items 3-9 that we don't like increases exponentially and likely will result in at least one if not multiple of these effects for a significant portion of our student population and community. The likely outcome will be the loss of one or more of the things we do like.

## 2. Mask mandate for K-12.

We have to deal with items 1 & 2 that we don't like. Frustrating, annoying, aggravating, etc. This option also allows us to get all the things we like. However, the overall likelihood of items 3-9 occurring decreases significantly and we can avoid most, if not all, of them. Therefore, we have a higher likelihood of getting to keep all the things we like.

As you can see, neither option allows us to get everything we like and nothing we don't, but being an adult and a contributing member of society means that compromises need to be made that are in the best interest for long-term benefit and keep our community and economy healthy and thriving. It's really that simple. Pass the mandate.

Dear Pima County Board of Supervisors,

I am the mother of a student attending first grade in CFSD this year, and I am extremely concerned about the current status of COVID-19 in the Tucson Community. With positive COVID infection cases and hospitalizations soaring in spite of Tucson's vaccination rate, I have serious reservations about allowing my daughter to continue attending school without the immediate assurance that all faculty, staff, and students will be wearing protective masks. Currently, our school district's policy is that masks are encouraged but they remain optional. We need YOUR help before they can take a stand. I recognize that our Governor has signed an executive order banning mask mandates; however, I believe this order is unjust, potentially unenforceable, and far from reflective of our current public health crisis. We know what the experts say. We know that the AAP and the CDC recommend masking our children. With COVID positive numbers rising in nearby school districts already in session, how can we possibly proceed as if there aren't continued, exceptional health concerns in our greater community? It is an unconscionable decision, I believe, to withhold protection for unvaccinated children.

I understand that the freedom to make choices is important to every parent. This is not about choices. This is about our civic responsibility to do everything we can to protect our children and the community at large. When children under age 12 are eligible for the vaccine, then I will be much more comfortable with a mask optional policy. # KEEPING KIDS SAFE

An evidence-based approach to protecting kids during the school year



The Centers for Disease Control and Prevention and the American Academy of Pediatrics strongly recommend that in order for schools to remain open, which is of critical importance to the education and wellbeing of children and families, certain public health measures must be instituted and adhered to, like universal mask wearing.

## Why now?

### Delta has changed the game

- Delta is 200% more transmissible and results in up to 1000x higher viral load compared to previous variants.
- This translates into a  $R(0)=6-10$ . Meaning, on average, one person infects 6-10 people. This is similar to the  $R(0)$  for chickenpox and higher than the  $R(0)$  for smallpox.
- Vaccinated individuals who become infected can spread the Delta variant to others.

## Kids don't have an immunity wall.



### Not enough kids are protected for an effective immunity wall

- For example, only 30% of children have SARS-CoV-2 antibodies in Texas, meaning a majority of kids have yet to be exposed to COVID-19 (Messiah et al., 2021).
- Many children haven't had the opportunity to be protected by the COVID-19 vaccine.
  - Only 12+ are eligible
- Not enough eligible adolescents are vaccinated.
  - Only 39% of 16-17 year-olds and 27% of 12-15 year-olds are fully vaccinated in the United States (AAP, July 28, 2021)

## We can do it safely during a pandemic.

### Study after study shows the effectiveness of a layered approach in K-12 schools

- In Missouri, schools that implemented masks, physical distancing, and increased ventilation had much lower transmission than in the community (Dawson et al., 2021)
- In Utah, despite high community incidence and an inability to space students' classroom seats  $\geq 6$  ft apart, high student mask use resulted in low transmission and no school-related outbreaks in 20 Salt Lake County elementary schools (Hershov et al., 2021)
- In rural Wisconsin, masking requirements and student cohorting within schools allowed transmission risk to remain low (Falk et al., 2021)
- A study in Florida found a layered approach is especially needed when community spread is high (Doyle et al., 2021)

## We need to do it for our kids' health.

### COVID-19 in kids can range from mild to severe illness

- As of July 22, 2021, over 4.1 million COVID-19 pediatric cases have been reported. The CDC estimates that the "true" burden is 26,838,244 pediatric cases in the U.S.
- In 23 states, 16,878 pediatric hospitalizations have been reported. The CDC estimates 209,264 cumulative pediatric hospitalizations in the U.S. as a whole.
  - Hospitalization rates for COVID-19 are higher than for the 2009-10 H1N1 pandemic.
- As of May 2021, 3,742 MIS-C cases have been linked to COVID-19.
- Over 400 pediatric deaths have been reported since the beginning of the pandemic. Although this seems low compared to adults, COVID-19 is now a top 10 cause of death for adolescents in the United States.
- Mortality is not the only negative outcome. Long COVID-19 (or Post-acute Sequelae of COVID-19 [PASC]) has been reported among kids.
  - The British National Health Service is reporting that 7-8% of kids experience long COVID-19 and is opening new pediatric clinics for long COVID-19 around the country.

## We need to do it for our community.



### We need to stop transmission among kids to stop spread in the community.

- Kids spread SARS-CoV-2 as efficiently as adults. Several outbreak investigations have demonstrated transmission among children, adolescents, and young adults, including transmission to older household members.
- Living with a child engaged with in-person school without public health mitigation measures increases the odds of COVID-19 for the household (Lessler et al., 2021)
- Children who got COVID-19 at two Utah daycares spread it to household members (Schwartz et al., 2020)

## A collective approach is far more effective.

### A collective approach is far more effective than an individualistic approach

- While masks provide protection to the wearer, they primarily serve as source control and the greatest benefits occur if everyone wears them.
- Kids are highly influenced by peers and teachers. If all peers are required to wear masks, social desirability will play a factor into compliance.
- Using vaccination status to determine who should wear a mask in schools will be a huge burden on teachers and staff and nearly impossible to enforce

According to Banner Health Chief Clinical Officer, Dr. Marjorie Bessel hospitals have seen a 95% increase in Covid-19 patients since July 1 and 300% increase in ventilators and there is substantial spread in the vast majority of Arizona counties. Arizona is also second in the nation for pediatric deaths related to COVID-19, according to data published recently by the American Academy of Pediatrics. The science around masking is settled. Masks work to prevent disease transmission. **Message Subject** Mandatory Masking and Vaccination of Healthcare Workers

Dear Julie Castaneda, Clerk of the Board, Once again I am writing to all the supervisors to be sure they are, once again, aware of my opinions (backed by real science) of the masking of our children and grand-children in particular and the mandated vaccination of healthcare workers and others. It is my hope that each of the supervisors will take the time, not only to read my comments, but to check on the references I have listed. It is my sincere hope you are not disregarding the references and my opinion because you see it as too controversial or heaven forbid, "misinformation." You are all intelligent individuals able to deal effectively with controversy and have the ability to critically think especially when you have both sides of an issue such as masking and vaccinating. Let me start with vaccinating against SARS-CoV-2. First of all, I am not an anti-VAXer. I worked in healthcare facilities and kept up to date on all the required vaccinations. None of those vaccinations were experimental. This SARS-CoV-2 vaccine is experimental. These vaccines are associated with increasing deaths and significant serious side effects. Since it appears to be easier to get accurate information about deaths and injury from the EU's database, (EudraVigilance), let me share with you what this database displays. There are 20,595 Dead and 1.9 million (50% serious) reported in the EU's database of adverse reactions for COVID shots. I could list the numerous side effects/complications with numbers but that would make my comments even longer than you might like. But feel free to go to <https://alethonews.com/2021/08/02/20595-dead-1-9-million-injured-50-serious-reported-in-eus-database-of-adverse-reactions-for-covid-19-shots/> There is a nice table summarizing the deaths and injuries according to each COVID vaccine. Pfizer and BioNTech's Covid-19 vaccine is just 39% effective in Israel where the delta variant is the dominant strain according to a new report from the country's Health Ministry. This is astonishing as not so long ago the vaccine manufacturers claimed their products were 92-98 percent effective. Even factoring for the variants, the hard data makes it quite clear that the initial claims of vaccine effectiveness were greatly exaggerated. Even CNN claims that even though Pfizer is only 39% effective, it still protects against serious

disease but this is simply not true. Again if you take the trouble to look into the data put out by the Israeli government, you will find there were 137 serious cases in Israel of which 95 were fully vaccinated and 42 unvaccinated or partially vaccinated. In other words, the bulk of the serious cases was comprised of those who had received their shots. Dr. Kobi Haviv, Director of Herzog Hospital in Jerusalem stated "that the fully vaccinated people account for about 90 percent of hospitalizations." If the vaccine was as effective in protecting against heavy (serious) illness as the CNN article claimed, then the numbers would look completely different. So now we have a vaccine that is much less effective not only at preventing infections and symptoms of COVID-19 but is also not very effective at preventing serious disease. So we have a vaccine that has caused more deaths and serious side effects than has ever been noted before for any other vaccine yet it is still being pushed on the citizens across the world even now looking the children as possible targets for the experimental injection. So let me ask you who have children and grand-children, will you have them vaccinated? Remember there are other treatments for anyone suspected of having early infection with the SARS-CoV-2 virus such as hydroxychloroquine, azithromycin, ivermectin, clindamycin, zinc, monoclonal antibodies, and more. These treatments are not associated with any significant side effects or death. So tell me again why you would support the vaccinations over these treatments? People who recover and most of them do, will have developed a long-lasting and robust immunity. Can't say that for the vaccines can we? So why do you want to vaccinate healthcare workers? Do you want them to be more at risk of serious infections and/or death or major complications? Half of health care workers have been vaccinated and half have not (or close to these numbers). If they all get the vaccine, who will be alive and or healthy enough to take care of other vaccination victims let alone others who are hospitalized for other health issues such as heart attacks or stroke (maybe even caused by the vaccines), etc. These vaccines do not do what they have been advertised to do and they are toxic to the human body (remember that S protein and what it does). Why would you condone their use? Could it be because you have heard only one side of the evidence? Now on to masking. You have already heard from me that the virus is about 0.125 microns in size while masks can only filter out particles the size of 0.30-0.80 or larger NOT SMALLER. You also have heard from me that children and teens have a 99.995% recovery rate and rarely suffer serious symptoms or complications from encountering the virus. And they do not transmit the virus to others. They too will develop a long-lasting and robust immune response to any further encounters with the virus and any of its variants. You also have heard of the physiological and psychological effects of wearing facemasks. Table 1 Physiological and Psychological Effects of Wearing Facemasks and Their Potential Health Consequences, page 3, Facemasks in the COVID-19 era by Baruch Vainshelboim. Let me remind you of some of those less than desirable effects: decreased blood oxygen, increased blood carbon dioxide, shortness of breath, decrease in blood pH levels, inflammation, increase in stress hormones such as cortisol, immunosuppression, fear, mood disturbances, insomnia, fatigue, compromised cognitive performance, and more. There are long-term consequences of wearing facemasks as well. The existing scientific evidence challenge the safety and efficacy of wearing facemasks as preventive intervention for COVID-19. The data suggest that both medical and non-medical facemasks are ineffective to block human-to-human transmission of viral and infectious disease such as SARS-CoV-1 and COVID-19. So do you still think masking of anyone let alone your children is an acceptable practice? Let alone mandating it for them while attending school? As a side note, I wonder how many of the cases in the Pima Country medical facilities are in previously vaccinated individuals and how many of them are seriously ill and in the ICU's? How many were hospitalized for other reasons and for some, odd reason (particularly if they were not

vaccinated) they were tested for COVID-19 (SARS-CoV-2) using PCR employing the 40-44 cycle threshold? Vaccinated individuals hospitalized should be tested as well and if so, was the PCR threshold set between 28-30 rather than 40-44? Interesting questions aren't they. Long though this response maybe, I hope you will give it the time it deserves and use this information as you make decisions that will affect the lives and livelihood of hundreds to thousands of Pima County residents.
