

Dear Pima County Board of Supervisors,

As the Chief Executive Officer of the Sunnyside Foundation, I am writing to ask for your support in the proposed Pima County budget of Pima CommunityShare within the Pima County School Superintendent's Office.

The Sunnyside Foundation has been a proud partner with Pima CommunityShare for five years through our Sunnyside CommunityShare (SCS) program. This transformative partnership serves Sunnyside Unified School District (SUSD), Tucson's second largest school district with over 12,000 students, 89% of whom are Hispanic/Latino and many from families living below the federal poverty level on Tucson's historically under-resourced south side.

Through our collaboration with Pima CommunityShare, we have created a nine-month fellowship program that has impacted 66 PreK-12th grade educators and more than 8,700 students to date. Pima CommunityShare's digital platform and human library of community professionals are essential components that make our program successful, connecting our educators and students to caring adults and professional mentors who prepare students for their future careers, college and life.

I have seen firsthand the deep impact this work has on students and educators. Through SCS, students have designed cities of the future powered by renewable energy, explored sustainability solutions, and developed authentic voices for advocacy and leadership. As one participating student shared, "This could really be the future of humanity. This is stuff that we might actually suggest and see in our city if we really push for it." Educators report significant increases in student engagement, social emotional learning, and student understanding of real-world applications of their learning.

Pima CommunityShare plays a critical role in supporting Pima County's Prosperity Initiative by connecting students in high-need neighborhoods like Sunnyside with critical educational opportunities and resources, ensuring they reach adulthood with the skills, tools, and resources for economic stability. Our partnership directly addresses educational and economic inequities faced by low-income students of color by cultivating their critical thinking, leadership and advocacy skills.




