Introduction/Background:

This Resolution authorizes the County Attorney's Office to acquire by the excercise of eminent domain real property and real property interests for the construction of the Southeast Interceptor Augmentation and El Paso and Southwestern Greenway Projects.

This Resolution will authorize the County Attorney to acquire property under the County's eminent domain authority where necessary for the projects to proceed to construction.

RESOLUTION OF THE PIMA COUNTY BOARD OF SUPERVISORS AUTHORIZING THE PIMA COUNTY ATTORNEY TO CONDEMN REAL PROPERTY INTERESTS WHERE NECESSARY FOR THE SOUTHEAST INTERCEPTOR AUGMENTATION AND EL PASO SOUTHWESTERN GREENWAY PROJECTS IN SECTIONS 24 AND 25 OF TOWNSHIP 14 SOUTH, RANGE 13 EAST, G&SRM

The Board of Supervisors of Pima County, Arizona finds:

- 1. Pima County plans to construct and maintain certain improvements in Sections 24 and 25, Township 14 South, Range 13 East, G&SRM.
- 2. The Board of Supervisors of Pima County finds it necessary exercise its powers of eminent domain, under A.R.S. §§ 11-932 and 12-1111, to acquire interests in the real property depicted in attached <u>Exhibit A</u> in order to construct public improvements, including wastewater facilities, multi-use paths, and related improvements, for the Southeast Interceptor Augmentation Project and El Paso Southwestern Greenway Project (collectively, "the Projects").
- 3. The Board of Supervisors of Pima County finds that condemning a portion of parcels 118-23-287C and 119-02-027D, depicted in the attached **Exhibit A**, will leave the remaining property in such a condition as to give rise to a claim or litigation concerning severance or other damage.




SECTION 24 & 25 TOWNSHIP 14 SOUTH RANGE 13 EAST
