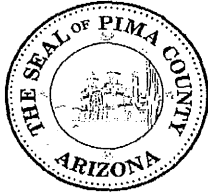



- Utilizing Incentives and Disincentives to Promote Vaccination of Pima County Employees.


After thorough discussion of the above items, individual motions were made regarding each of the above items.
