Title: Sycamore Leaf Road No Stopping, Standing or Parking

Introduction/Background:

The reason for this ordinance is to establish portions of Sycamore Leaf Road as No Stopping, Standing or Parking in the vicinity of Copper Ridge Elementary School.

Discussion:

Pima County Traffic Engineering staff observed pedestrian and vehicular activity in the vicinity of Copper Ridge Elementary School. Vehicles were observed parking along Sycamore Leaf Road and dropping off students rather than utilizing the pick up and drop off areas on the school grounds. In addition, No Stopping, Standing or Parking of vehicles should be implemented in the area of the school crosswalk to minimize exposure of school aged pedestrians and vehicles. The School was notified that Pima County Traffic Engineering would be installing signs to prevent stopping, standing or parking along Sycamore Leaf.

Conclusion:

Pima County Traffic Engineering recommends portions of Sycamore Leaf Road be established as No Stopping, Standing or Parking based on field observations by staff to minimize pedestrian and vehicular conflicts.

Recommendation:

Pima County Traffic Engineering recommends both sides of Sycamore Leaf Road from 800 feet east of Rustling Leaf Trail to 690 feet west of Rustling Leaf Trail be established as No Stopping, Standing or Parking.

Fiscal Impact:

Minimal.

ORDINANCE NO. 2016-___

AN ORDINANCE OF THE PIMA COUNTY BOARD OF SUPERVISORS REGULATING PARKING ON SYCAMORE LEAF ROAD IN PIMA COUNTY, ARIZONA

WHEREAS, the Board of Supervisors of Pima County, Arizona, has the authority under Title 28 of the Arizona Revised Statutes, more specifically Sections 28-627 and 28-873, as amended, to regulate the stopping, standing or parking of vehicles, and

WHEREAS, the Board of Supervisors of Pima County, Arizona, has determined that it is in the interest of public safety that vehicles should not park on both sides of Sycamore Leaf Road from 800 feet east of Rustling Leaf Trail to 690 feet west of Rustling Leaf Trail,

THEREFORE, IT IS HEREBY ORDAINED by the Board of Supervisors of Pima County, Arizona, that:

- **SECTION 1.** Parking on both north and south sides of Sycamore Leaf Road from 800 feet east of Rustling Leaf Trail to 690 feet west of Rustling Leaf Trail shall be regulated No Parking, specifically No Stopping, Standing or Parking.
- **SECTION 2.** Any ordinances or parts of ordinances in conflict herewith are superseded to the extent of such conflicts.
- **SECTION 3.** This ordinance shall take effect when and to the extent that signs are posted on the highway herein listed giving notice of the parking restriction.
- **SECTION 4.** Violators of this ordinance shall be subject to civil or criminal sanctions as provided by law.

SECTION 5. The various county officers and employees are authorized and directed to perform all acts necessary or desirable to give effect to this ordinance.
